

Claim denied for shoulder surgery/rotator cuff. Conservative estimate of surgery, medical \$58,000.00, TTD 8 wks. x \$892.00 = \$7,136.00, PPD at 5% 25 wks. x \$322.00 = \$8,050.00. Savings \$58,000.00 + \$7,136.00 + \$8,050.00 = \$73,186.00	\$	73,186.00

Claim denied for carpel tunnel, conservative estimate, medical \$15,000.00, TTD 8 wks. x \$599.67 = \$4,789.36, PPD at 3% 12 wks. x \$322.00 = \$3864.00. Savings \$15,000.00 + \$4,789.36 + \$3,864.00 = \$23,653.00	\$	23,653.00
#3 Streets and Sanitation Department Claim denied for back injuries. Saved 3 days of lost time, with early RTW 3 days x 8 hrs. x \$23.88 = \$573.12. Plus conservative estimate of medical, PPD, TTD, injections etc. \$20,000.00. Savings \$20,000.00 + \$573. 12 = \$20,573.00	\$	20,573.00

Hearing loss claim denied. Conservative estimate for potential exposure includes several sets of hearing aids and PPD is \$30,000.00. Savings \$30,000.00	\$	30,000.00

Got employee back on light duty 4hrs. x 10 days x \$30.29 = \$1,211.60, 2 hrs. x 10 days x \$30.29 = \$605.80. Savings \$1,211.60 + \$605.80 = \$1,817.40	\$	1,817.00
#6 Fleet Services Claim denied for left shoulder tear that would have required surgery. Conservative estimate medical \$40,000.00, PPD at 5% = \$8,050.00, TTD 2 wks. x \$724.80 = \$1,449.60. Savings \$40,000.00 + \$8,050.00 + \$1,449.60 = \$49,549.00	\$	49,549.00
#7 Police Department Court ordered restitution by defendant. Savings \$1,822.38	\$	1,822.00
# 8 Water Department Claim denied for radiculitis, TTD 4 wks x \$ 792.37 = \$ 3,169.48, medical \$15,000.00. Savings \$3,169.48 + \$15,000.00 = \$18,169.48	\$	18,169.00
#9 MRI Incentive Program (adopted August 5, 2014)	· ·	,
Average cost of MRI \$2,800.00. 3 MRI's x \$2,800.00 = \$8,400.00. We paid 2 MRI's x \$600.00 = \$1,200.00, 1 MRI x \$540.00 = \$540.00, 3 incentives 3 x \$100.00 = \$300.00. Savings \$8,400.00 - \$2,040.00 (\$1,200.00 + 540.00 + \$300.00) = \$6,360.00.	\$	6,360.00
#10 CT Scan Incentive Program (adopted July 21, 2015) Average cost of CT Scan \$1,800.00. 2 CT Scans x \$1800.00 = \$3600.00. We paid 1 CT scan \$1,800.00 - \$400.00 (no incentive paid) = \$1400.00, 1 CT scan \$1,800.00 - \$400.00 + \$50.00 = 1,350.00. Savings \$3,600.00 - \$850.00 (\$400.00 + \$450.00) = \$2,750.00.	\$	2,750.00
