Resolution relative to accepting the proposals of ASD Healthcare and Aventis Pharmaceuticals for furnishing and delivering 375 vials of Flu Vaccine for a total sum of \$25,820.00.

WHEREAS, The Purchasing/Central Services Division has reported that it has received a cooperative proposal through the Minnesota Multistate Contracting Alliance for Pharmacy (MMCAP) from the State of Wisconsin Dept. of Health and Family Services for furnishing and delivering 375/10 dose vials of influenza vaccines for the Health Department of the City of West Allis, that the proposal received was reasonable; and,

WHEREAS, The Common Council deems it to be in the best interests of the City of West Allis that the proposal of ASD Healthcare and Aventis Pharmaceuticals, Inc. be accepted.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Common Council of the City of West Allis that the letter dated January 29, 2003 submitted by The State of Wisconsin Dept. of Health and Family Services awarding the contract to ASD Healthcare for furnishing and delivering 350 vials of Fluviron at \$67.70/vial and Aventis Pharmaceuticals, Inc. for providing 25 vials of flu vaccine approved for children at \$85.00/vial for a total net sum of \$25,820.00 be and is hereby accepted.

BE IT FURTHER RESOLVED, that the Purchasing/Central Services Division be and is hereby authorized to issue a purchase order for the aforesaid material.
