NARRATIVE

INITIAL CALL

On 11/09/14 at approx. 0036 hrs, officers responded to Tap 58 Bar 5732 W Mitchell St for 20 people fighting. Upon arrival, I observed a large group of people standing outside Tap 58. I spoke with a male later identified as, Brad M Lyons (M/W, 11/07/77).

STATEMENT OF BRAD LYONS

Brad stated he was at Tap 58 celebrating his birthday when a fight broke out between two males. Brad told me the fight was resolved very quickly, and both "problem" parties left. As he was standing in the road by the driver's side door, talking with one of the males who was involved in the fight, a black Cadillac Escalade came around the corner, and hit Brad causing him to fall to the ground. Brad immediately got back up on his feet, and observed his

cousin's husband, "Robert" in the driver's seat before he drove off. Brad could not provide me any more information on Vazquez, or the vehicle he was driving. I asked Brad several times if he was injured and needed an ambulance and he told me he was a little sore, but did not want an ambulance.

OFFICER OBSERVATIONS

As I was speaking with Brad, I did not observe any marks on him, and he appeared at the time to be walking fine. He was advised if he did seek medical treatment at a later date he would have to contact me to let me know where he received his treatment.

LACK OF CONSENT

Brad did not give permission to Vazquez to strike him with his vehicle at anytime.

FOLLOW UP

On 11/09/14, I attempted to make contact with Robert via phone, but was unsuccessful. I left a message and as of 11/19/14, he has not returned my phone call.

On 11/11/14, Brad left me a voice mail message stating he did receive medical treatment for some bruises on his legs. He also informed me the name of the driver who struck him was Guadalupe R. Vazquez. The only other information he could provide me with about Vazquez was his address, 2541 S 43 St, #208. 414-207-5540

On 11/12/14, Brad came into the station and signed the Medical Release Form, and provided me with a copy of his medical paperwork.

On 11/12/14, I attempted to make contact with Vazquez at his apartment. I was unable to make contact with Vazquez, and due to underground parking, was unable to obtain any information on Vazquez's vehicle.

On 11/18/14, I spoke with Brad via phone, and he still could not provide me with any more information on Vazquez. Brad told me if he obtained any more information he would leave myself, and Sgt. Kempinski a voice mail message.

CASE DISPOSITION

Officers responded to Tap 58 for a large fight. Further investigation revealed Brad M Lyons was struck by a vehicle traveling at a very low speed. It appeared Brad did not suffer any injuries, and refused any medical treatment. Several attempts were made to make contact with Guadalupe R Vazquez, who may have been

STATEMENT OF OMAR A ESCOBEDO

Omar was standing outside of Tap 58, 5732 W Mitchell St, when he observed Brad Lyons attempting to break up a fight between two unknown males on the south east corner of W Mitchell St/S 58 St near a red truck. Omar stated Brad stepped in between the parties and broke them up. One of the males left the area and proceeded to a black truck near the intersection of S 58 St/W Mitchell St.

The black truck pulled up along the red truck on W Mitchell street facing E/B. The driver of the black truck stopped for a few seconds then pulled forward striking Brad in the leg, causing him to fall to the ground on his back. Omar explained he heard Brad yell in pain after getting hit and rolled on the ground. After the driver of the black truck struck Brad, the driver backed up then proceeded forward towards Brad like he was going to hit him again. Brad rolled out of the way to avoid getting hit. The black truck was last observed driving E/B on W Mitchell St.

Omar was unable to give a physical description of the driver in the black truck.

Upon arrival, the altercation had ceased; however, there was a male party claiming to have been struck by a vehicle in the process of two parties involved fleeing the scene. Cpl. McNally spoke with this male, while Sgt. Kempinski and I went inside of the bar to speak with the managing bartender, Jennifer M. Munson, F/W 06-06-80.

Munson stated the bar was holding an event / birthday party for the alleged victim, Brad M. Lyons, M/B 11-07-77. Munson advised she was unaware of any altercation or issues outside of the bar, as there were no known problems with the patrons inside. Munson provided the bar license and was compliant with all of officers' requests. Munson was advised to monitor the patrons who went outside to smoke and / or loiter in front of the building, so further issues could be avoided.

INITIAL OBSERVATIONS

On 11-9-14 at approximately 0034 hrs, Squad 311 responded to the tavern Tap 58, 1702 S 58 ST for report of approx. 20 people fighting in front of the establishment. Upon arrival on scene I found a large crowd of people in front of the establishment and a male, who identified himself as Israel A. Gonzalez (m/h, 12-29-80) and stated that he saw some of what took place.

ON SCENE CONTACT WITH BAR PATRON / WITNESS - ISRAEL A. GONZALEZ (M/H, 12-29-80)

Israel A. Gonzalez stated he was at the Tap 58 Tavern with his wife and his wife's cousin "Brad", who was outside with some people that Israel did not know personally. Israel came outside to smoke with his wife when they saw that "Brad" was on the ground and a dark SUV was taking off eastbound on W Mitchell St. Israel stated that it appeared "Brad" was rolling out of the way to avoid the vehicle striking him.

Israel said he did not believe that "Brad" knew the people in the dark SUV, but he did think that they were acquaintances of "Brad."

Israel added that just after the dark SUV took off a maroon colored SUV took off following the vehicle in the same direction.
