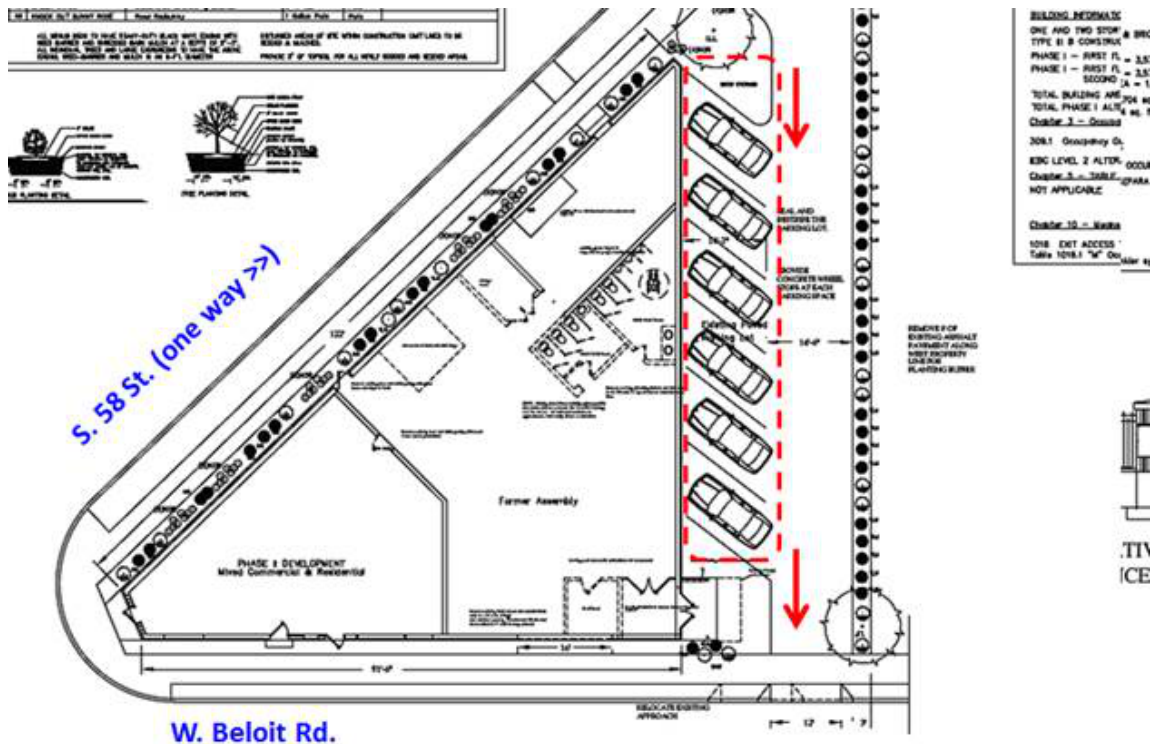

I will get back to the neighbor, Ms. Zaren, but to help answer the question: Planning is not aware of any plans to change S. 58 St. to a two way street, however, the Plan Commission recommended altering the flow of traffic through the parking lot of the liquor & grocery store to run from south to north (enter from S. 58 St. and exit onto W. Beloit Rd.). This would help alleviate traffic from leaving the site and turning south into the neighborhood.
