**RESOLUTION TO ACCEPT THE SINGLE SOURCE PROPOSAL OF SHERWIN
INDUSTRIES, INC. FOR FURNISHING AND DELIVERING ONE ASPHALT HOT
BOX TRAILER FOR \$74,760**

WHEREAS, the Public Works Streets Division must replace an old asphalt hot box which has been retired due to numerous maintenance issues; and

WHEREAS, item #25 in the 2026 Capital Improvement Program approved budget includes \$95,000 for the purchase of the asphalt hot box trailer; and

WHEREAS, Sherwin Industries, Inc. has provided pricing for the Spaulding 4-ton Roadsaver oil jacked asphalt hot box trailer; and

WHEREAS, the Spaulding oil jacked Roadsaver hot box is the only manufacturer to utilize thermosiphoning technology with one burner in their hot box. This is an advanced heating system which provides more efficient and consistent heat circulation throughout the hopper utilizing fewer moving parts which reduces maintenance and operating costs. Their construction also includes the heaviest gauge steel in the industry for increased longevity; and

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that this contract meets all desired specifications, and that the proposal of Sherwin Industries, Inc. is reasonable.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the proposal dated June 17, 2026 by Sherwin Industries, Inc. for furnishing and delivering one Spaulding 4-ton Roadsaver oil jacked asphalt hot box trailer for a total sum of \$74,760 is accepted.

BE IT FURTHER RESOLVED that this purchase will be charged to Account Number 352-4218-535-7003.

BE IT FURTHER RESOLVED that the Finance Department is authorized to enter into a contract for the aforesaid equipment.
