The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of September and a few dates in August.

Incident reports:

Case # 11-007271, 08/12/2011, at approx. 0044 hrs. Alibi Tavern, 6540 W. Grant St.

On 08/12/11, at approx. 0044 hrs, officers were dispatched to the Alibi Tavern; 6540 W. Grant St regarding a trouble call. The investigation revealed that several bar patrons were involved in a physical altercation in the tavern; however, they left before officers arrived. The bartender reported that there was complete chaos in the bar during the fight; she said pint glasses were thrown along with a chair. She tried to break the fight up, but it was out of control (approx. seven patrons were fighting).

The bartender provided the name of two individuals that were involved in the fight. In addition, two other individuals came into the station to file a complaint and wanted charges pursued against the individuals that assaulted them. Ongoing investigation.

Case # 11-007822, 08/29/2011, at approx. 1359 hrs. Walsh's Beer & Liquor, 10910 W. Greenfield Ave.

On 08/29/2011, at approx. 1359 hrs, Det. Donigain and Canine Officer Zientek conducted compliance checks for the sale of synthetic marijuana (K-2).

On the above date and time Det. Donigain entered Walsh's Beer & Liquor store (10910 W. Greenfield Ave) and asked the clerk if he sold any K-2. The clerk retrieved from under the counter a product called "Mr. Happy." After Det. Donigain and Officer Zientek examined the package and determined this was synthetic marijuana - in violation with our city ordinance. Officers subsequently received consent from the owner to examine other product that was located under the counter; several items were located and also determined to be in violation of our city's K-2 ordinance. The clerk / owner was advised of the violation and that he would be cited for selling these products. (ACA Jenna Merten confirmed that the aforementioned items being sold were in violation of the city's ordinance pertaining to the sale of synthetic marijuana).

Case # 11-007822, 08/29/2011, at approx. 1408 hrs. Cigarette Depot, 7023 W. Greenfield Ave.

On 08/29/2011, at approx. 1408 hrs, Det. Donigain and Canine Officer Zientek conducted a compliance check synthetic marijuana K-2 at the Cigarette Depot (7023 W. Greenfield Ave). Officers entered the Cigarette Depot and asked the clerk if he had any K-2. The clerk retrieved a container of several products; these items were determined to fall into the category of synthetic marijuana. The clerk was advised that he was going to be issued a citation for selling synthetic marijuana. (ACA Jenna Merten confirmed that the aforementioned items being sold were in violation of the city's ordinance pertaining to the sale of synthetic marijuana).

Case # 11-007911, 09/01/2011 at 0141 hrs. Sportz Medicine, 7731 W. Becher St.

On 09/01/2011, at approx. 0149 hrs, Officers responded to Sportz Medicine (7731 W. Becher St) regarding a trouble call. Investigation revealed that a physical altercation between several parties occurred. Two parties were arrested for physically hitting and spitting on other patrons. One party received three citations for the following: Disorderly Conduct, Obstructing an Officer and Consumption of an Alcoholic Beverage by an Underage Person. The second party was cited for Disorderly Conduct.

Case # 11-008056, 09/03/2011 at 1947 hrs. Walk Her Inn Tavern, 900 S. 74th St.

On 09/03/2011, at approx. 1947 hrs, Officer Blunt was dispatched to The Walk Her Inn Tavern regarding an anonymous report of a 20-year-old female drinking alcohol at the bar. Officer's investigation revealed that a twenty-year-old female was being served alcohol at the bar. The underage female is going to be cited for Underage Alcohol Consumption. The bartender said he believed the female was 21 years of age because that is what she told him. He did not ask her for an ID. He is being issued a citation for Selling Alcoholic Beverage to an Underage Person.

Call # 11-038295, 09/04/2011 at 0229 hrs. Johnny Hammers Tavern, 6300 W. Lincoln Ave.

On 09/04/11, at approx. 0229 hrs, officers were dispatched to Johnny Hammers Tavern (6300 W. Lincoln Ave) regarding a trouble call. Investigation revealed that an unknown party attempted to instigate a fight with a patron because he was on crutches. The party on crutches subsequently threw one of his crutches at a female that was arguing with him (unrelated to the person who tried to instigate the fight). Parties were advised of the disorderly conduct ordinance and sent on their way without further incident.

Call # 11-039215, 09/10/2011 at 0209 hrs. Junebugs Tavern, 6231 W. Mitchell St.

On 09/10/11, at approx. 0209 hrs, officers were sent to Junebugs Tavern (6231 W. Mitchell St) regarding several patrons yelling at people across the street. No disposition given by officer .

Call # 11-039394, 09/11/2011 at 0026 hrs. Walk Her Inn Tavern, 900 S. 74th St.

On 09/11/2011, at approx. 0026 hrs, Officer Cato was dispatched to the Walk Her Inn Tavern (900 S 74th St) regarding a request for assistance. This investigation revealed that there was a verbal argument between a male and female in front of the tavern. The male party took the female's vehicle and their 1-year-old child. Officers located the child at the maternal grandmother's residence in Milwaukee.

Case # 11-008259, 09/01/2011 at 0231 hrs. Sportz Medicine, 7731 W. Becher St.

On 09/11/2011, at approx. 0231 hrs, Officers responded to a complaint of several parties fighting in the bar. Upon officers arrival several individuals fled in different directions. Two parties were located in the middle of the street; both were bleeding from the mouth and nose. These individuals pointed out the two persons they thought were responsible for assaulting them. The two offenders fled from officers, but were subsequently caught and arrested for Hindering / Obstructing. Officers were unable to prove that these subjects were the actors responsible for assaulting the aforementioned individuals who were bleeding in the street.

Case # 11-008289, 09/12/2011 at 0210 hrs. Flappers Tavern, 7527 W. Becher St.

On 09/12/2011, at approx. 0210 hrs, Officer Gold was on patrol in the 7500 Blk of W. Becher St. Officer Gold observed a male party urinating in the alley (2100 block) between 75th / 76th St . This party was subsequently arrested for disorderly conduct.

Case # 11-008322, 09/13/2011 at 0234 hrs. PM Pub & Grill, 6533 W. Mitchell St.

On 09/13/11 at 0234hrs, I responded to PM Pub & Grill (6533 W. Mitchell St.) for a burglary call. Investigation revealed two black males in their mid twenties wearing all black clothing and bandanas, robbed John Monty, Aidan Kiesner, and Michelle Monty at gunpoint. At this time there are no suspects in this case.

Case # 11-008351, 09/13/2011 at 2356 hrs. Double Barrel Saloon, 1100 S. 60th St.

On 09/13/2011 at approx. 2356 hrs, Officers responded to the 5800 block of W. Scott St regarding a male party who was being chased. The officers' investigation revealed that a male party was causing problems while in the Double Barrel Saloon and was asked to leave. Once outside, the bartender reportedly pointed a black semi-auto blank pistol at him and told him to leave. After this party fled the bartender pointed the pistol at a second male subject came around the corner to see what the commotion was.

Officers conducted a consent search of the tavern and a pistol was found matching the description above. The bartender was taken into custody and ordered to the District Attorney's Office. The bar was subsequently closed down for the night.

Call # 11-040344, 09/17/2011 at 0021 hrs. Junebugs Tavern, 6231 W. Mitchell St.

On 09/17/2011 at approx. 0021 hrs, Officers responded to Junebugs Tavern (6231 W. Mitchell St) for a complaint of smokers being loud outside. Contact was made with the owner who was advised to monitor the noise level outside and close the bar door to prevent excessive noise.

Case # 11-040357, 09/17/2011, at approx. 0225 hrs. The Drunken Duck Tavern – 5906 W. Burnham St.

On 09/17/2011, at approx. 0225 hrs, Officer Tuschl was monitoring bar closing traffic in the 1900 block of S. 60th St. He observed two male parties verbally arguing in front of the Drunken Duck Tavern, located at 5906 W. Burnham St. Parties were sent on their separate ways without incident.

Case # 11-008484, 09/18/2011 at 0226 hrs. Sportz Medicine, 7731 W. Becher St.

On 09/18/2011, at approx. 0226 hrs, Officers responded to a fight call outside of Sportz Medicine (7731 W. Becher St). The initial call indicated that approx 20 persons were involved in the fight. Two male subjects were eventually arrested for multiple charges: Possession of THC, Hindering an Officer, Disorderly Conduct; in addition, an order to detain was issued by Probation and Parole.

Call # 11-040741, 09/20/2011 at 0118 hrs. Night Court Tavern, 7127 W. National Ave.

On 09/20/2011, at approx. 0118 hrs, Officer Gold was traveling W/B on National Ave when he observed a female standing in front of Night Court Tavern (7127 W. National Ave). The female made an obscene gesture toward Officer Gold with both her hands and also yelled, "Fuck You." Officer Gold reprimanded her for her actions/ profanity.

Case # 11-008579, 09/21/2011 at 0129 hrs. Ubie's Double Vision, 5501 W. Burnham St.

On 09/21/2011, at approx. 0129 hrs, Officers responded to Ubie's Double Vision Tavern (5417 W. Burnham St) for a report of a female down on the ground bleeding.

Investigation revealed that a M/H punched a female patron in the nose over a pool game. The female victim suffered a fractured nose. The offender fled the scene and there are no suspects at this time.

Case # 11-008614, 09/22/2011 at 0023 hrs. Sportz Medicine, 7731 W. Becher St.

On 09/22/2011, at approx. 0023 hrs, Officers were dispatched to the vicinity of Sportz Medicine (77 & Becher) regarding a report of 7 males fighting in the area. Upon officers arrival they observed several parties arguing in front of the bar. Officers advised the parties to leave the area. Meanwhile a F/W began causing a disturbance by yelling obscenities in the street. Next, a M/W party began yelling derogatory comments toward officers; this person was subsequently arrested because he refused to leave the area. Search incident to his arrest resulted in the recovery of a 3 " folding knife from his left pocket. This person was issued citations for Disorderly Conduct, Resisting an Officer and CCW. After he was cited, he refused to leave the area and was issued an additional citation for Disorderly Conduct. (2nd incident at this bar in less than 2 hours).

Case # 11-008615, 09/22/2011 at 0130 hrs. Sportz Medicine, 7731 W. Becher St.

On 09/22/2011, at approx. 0023 hrs, officers were observing the bar crowd due to a previous incident / problem earlier in the evening (above incident). Officers were alerted that a fight had broken out inside the bar. Three parties were subsequently arrested for Disorderly Conduct / Fighting. One of the offenders received an additional Disorderly Conduct ticket during the booking process.

Call # 11-041203, 09/23/2011 at 0003 hrs. Walk Her Inn Tavern, 900 S. 74th St.

On 09/23/2011, at approx. 0003 hrs, Officer Mathy responded to the Walk Her In Tavern (900 S. 74th St) regarding a noise complaint. Officer Mathy contacted the owner of the bar, she stated a male patron was arguing with an unknown female.

The male patron involved in the argument was subsequently identified. He stated he was involved in a verbal argument with a friend who has since left the bar. All parties were advised to keep the noise down.
