Mr. O'Sullivan stated the cost for a noise barrier to block the sound of the pulsars was very expensive and there is not proof that would alleviate the problem. He said Motor Castings is still shutting the pulsars off at night, per the previous agreement.

Mr. O'Sullivan did not have any witnesses to address the Committee. There were no objections from the audience. One (1) communication was received signed by Mr. & Ms. Skinner and Ms. Sura, regarding other noises from trucks and metal being moved about in the yard area.

Sally Nusslock, Heath Commissioner, stated the Health Department had received no complaints and were still doing random checks of the noise and vibration levels. Ms. Nusslock said she would contact Mr. & Ms. Skinner and Ms. Sura regarding their communication.
