**RESOLUTION TO APPROVE BID OF MJ CONSTRUCTION, INC. FOR STORM
SEWER INSTALL & SANITARY SPOT RELAYS IN S. 73RD ST. FROM 120' SOUTH
OF W. GREENFIELD AVE. TO W. GREENFIELD AVE AND VARIOUS LOCATIONS
AROUND THE CITY OF WEST ALLIS IN THE AMOUNT OF \$61,503**

WHEREAS, The Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received as shown on the attached bid report were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of MJ Construction, Inc. for 2022 Project No. 16 be accepted.

NOW THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of MJ Construction, Inc. for 2022 Project No. 16 for the storm sewer installation, sanitary sewer spot relays and pavement restoration in:

South 73rd Street from 120' south of West Greenfield Avenue to West Greenfield Avenue
Various Locations Around The City of West Allis

(PLAN FILE NOS. U-2683, X-929)

for the sum of Sixty-One Thousand, Five Hundred Three dollars (\$61,503) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be installed with funding by sanitary & storm sewer utility funds.
