## SUMMARY

### PO Kaye Reports: Disorderly Conduct/Resisting/Obstructing

On 03/30/13 at approximately 0221hrs, officers responded to 8924 W Schlinger Ave, for a report of 15 people fighting. Upon arrival I observed several individuals fighting in the middle of W Schlinger Ave. Darrell K. Harris (M/U 03/29/89) attempted to evade me while I was trying to stop him and speak with him about the incident. Darrell continued to walk away from me and attempted hide behind a vehicle in the parking lot of Shepherd's Sports Lounge. Darrell then attempted to flee the scene and officers took him to the ground. While on the ground Darrell fought with officer. Several knee strikes were given to Darrell as he would not listen listen to officer commands and place his hands behind his back. PO Binter used his Electronic Control Device on Darrell to gain control of him. Jessica L. Harris (F/W 06/13/83) interfered with officers multiple times while we were attempting to place Darrell in handcuffs. Darrell was arrested for

NARRATIVE

PO Kaye Reports:

On 03/30/13 at approximately 0221hrs, officers responded to 8924 W Schlinger Ave, for a report of 15 people fighting. Upon arrival I observed several individuals fighting in the middle of W Schlinger Ave outside of Shepherds Sports Lounge.

I was the first officer to arrive on scene and when I activated my overhead emergency lights, the fight stopped and all the individuals involved in the altercation proceeded to flee. The initial scene was completely chaotic. As I approached the scene on foot I estimated there to be approximately 20-30 individuals in the area. It was unclear as to who was all involved.

I initially observed a gray or white 4 door vehicle, which was running, with several individuals in it, stopped on S 90 St at W Schlinger Ave, facing north. The vehicle was attempting to leave the area. I advised the driver, who was a W/F, to stop and stay where she was. While giving commands to the W/F driver I observed a different female running south on S 90 St. I ordered this female to stop several times, flashing my flashlight at her on and off, to which she did not listen. After several attempts to stop her, she finally did, and I ordered her to stay where she was. **Note:** Both the vehicle and the second female fled the scene before other officers arrived and were able to speak with them.

I continued to approach the area where the fight had occurred. Several individuals were fleeing from the area. I observed a male, later identified as Darrell K. Harris (M/U 03/29/89), leaving the scene where the fight had just occurred. Darrell was headed towards Shepherds. I shined my flash light at Darrell, turning it on and off to get his attention, giving him commands to stop. Darrell continued towards Shepherds. **Note:** Darrell was not running, but "moving with a purpose" to get away from me.

While Darrell continued towards Shepherds I observed Darrell look back at me, but he continued to ignore my commands. I followed Darrell into the parking lot of Shepherds. Darrell proceeded to walk behind a black SUV and crouch down in

attempts to hide from me. Darrell had his hands on the front left corner panel of the vehicle while he was crouched down.

I approached Darrell, stopped on the opposite side of the black SUV (front right corner panel of the vehicle), and ordered him to stop. Darrell stood up, used some profanity towards me, and proceeded to walk away from me again. I observed Darrell's hands with cuts/blood while he had them on the hood of the vehicle.

It was apparent Darrell was involved in the fight that had occurred. Due to the fact Darrell would not listen to officer commands, the fact Darrell continued to walk away from me, the fact he attempted to hide from me, and attempted to flee me for a second time (All which are resistive behavior), I took Darrell to the ground by grabbing Darrell from behind, around his torso, with my right arm between his neck and right shoulder, pulling him backwards to the ground. **Note:** Darrell is 605 and 209lbs.

**RESISTIVE EPISODE**

While on the ground with Darrell and attempting to gain control of Darrell's hands to place him in handcuffs, PO Binter and PO Baumgart arrived to my location to assist me. Darrell would not give officers his hands, instead Darrell resisted officer attempts to place his hands behind his back by holding his arms under his body close to his chest. At one point Darrell attempted to get up off the ground by placing one of his hands on the ground and lifted his body up off the ground. Darrell was pushed back to the ground. Darrell continued to trash his body around, kicking his legs, rolling side to side, all while keeping his hands/arms close to his chest. Darrell continued to resist officers and held his hands in close to his chest.

While attempting to gain control of Darrell and his hands/arms, I delivered 4-6 knee strikes to Darrell's back in attempts to incapacitate him so officers could gain control of Darrell. This did not work, Darrell continued to resist officers. Due to Darrell's continued resistive behavior, the lack of response to the knee strikes, PO Binter proceeded to use his Electronic Control Device (ECD) on Darrell. (See PO Binter's Supplemental Report)

After PO Binter used his ECD on Darrell, officers were immediately able to place Darrell in handcuffs.

**Note:** While attempting to gain control of Darrell, several other individuals crowded around officers, one of which attempted to interfere with officers. Also the scene was still chaotic at this point with cars attempting to leave, individuals leaving from the bar, and people standing all around. Other officers were arriving at this point.

During the physical altercation with Darrell a W/F, later identified as Jessica L. Harris (F/W 06/13/83), attempted to interfere with officers while we were trying to place Darrell into handcuffs. Jessica approached officers and tried to push

officers off of Darrell (as Darrell is her cousin). Jessica was pushed backwards by officers to which she fell to the ground. Jessica attempted to interfere with officers a second time and I kicked Jessica somewhere in the lower body to keep her away. After Jessica was kicked she became very angry and started to yell at officer telling me I could not kick her like that.

After I placed Darrell in handcuffs, I immediately grabbed Jessica by the arm and was going to place her in handcuffs. Jessica immediately pulled away from me, and continued to yell and use profanities towards me telling me not to touch her. I grabbed Jessica again by the arm to which she resisted again but was unable to pull away. I placed Jessica in handcuffs. I handed Jessica over to PO Moews to be searched. While I was walking away Jessica stated she wanted to headbutt me.

#### OFFICER INJURY

While fighting with Darrell I sustained several open cuts/scrapes to my right knee which I was bleeding from (my pants were ripped during the altercation on my right knee) and several scrapes to my left knee. The injury most likely occurred during the take down of Darrell as my knees landed on the concrete. No medical attention was needed.

involved in the fight. Shelley stated she observed Darrell try to walk away from me and fight with officer while on the ground.

Shelley said she is Jessica's aunt. Shelley stated she observed Jessica attempt to interfere with officers but trying to get officers off of Darrell when officers were attempting to place Darrell in handcuffs. Shelley advised she also heard Jessica state she was going to headbutt me.

Shelley stated both Darrell and Jessica should have listened to officers and not do what they did.

**ARREST DECISION**

Based on the fact Darrell was scene leaving the scene of the fight, knowingly attempted to evade and hide from me, and fought with officers, Darrell was arrested for Disorderly Conduct and Resisting an Officer. Darrell was conveyed to the West Allis PD for booking.

Based on the fact Jessica attempted to interfere with officers two times while attempting to gain control of Darrell, and the fact Jessica pulled away from me when I attempted to put her in handcuffs, Jessica was arrested for Disorderly Conduct and Obstructing an Officer.

**IN CUSTODY STATEMENT - JESSICA L. HARRIS**

On 03/30/13 at approximately 0340hrs, I interviewed Jessica in Interview Room A of the WAPD booking room. I read Jessica her Miranda rights from WAPD Directive 42.016 (adult), and she stated that she understood her rights and would speak to me about this matter without an attorney present. The interview was recorded on an Olympus DS-2200 Digital Voice Recorder (Recorder# P15), using audio media card# P15.

The following is a synopsis of that interview:

Jessica explained she was at her cousin's (Darrell's) surprise birthday party. Jessica said she went to Shepherds at around 2130hrs (on 03/29/13) and left at bar close. Jessica stated she consumed three drinks and three shots, and believes she was intoxicated.

Jessica advised she was in a vehicle when the police arrived. Jessica said she was not involved in the fight. Jessica explained "Angie Sanchez" and her boyfriend "Jordan" were involved in the fight. Jessica stated another one of her cousins named "Damin" was involved in the fight but could not say for sure if Darrell was involved.

Jessica said "Angie Sanchez" and "Jordan" got into a white 4 door vehicle, possibly a Saturn, and left the area. Jessica said the vehicle was parked facing

north on S 89 St. **Note:** I believe "Angie Sanchez" and "Jordan" were in the vehicle I initially contacted on my approach to the scene and advised to stay where they were. I believe Jessica was confused to which street she was talking about and meant S 90 St.

I asked Jessica if she interfered with officers while arresting Darrell and she said she probably did - 'Shaking her head yes.' Jessica said she remembers getting pushed back by officers when she attempted to interfere and remembers me kicking her back the second time. I asked Jessica if she remembers saying she was going to headbutt me while on scene and she nodded in agreement. During the last part of Jessica's statement she began to well up while admitting to interfering with officers and saying she was going to headbutt me.

The interview ended at approximately 0350hrs. The audio media card was later sealed in a Digital Media Card Envelope, and placed in the Digital Media Card Slot in the Forensic and Technical Services Bureau as evidence.

**CASE DISPOSITION**

Officers responded to Shepherds Sports Lounge for a report of 15 individuals fighting in the street. Darrell K. Harris (M/U 03/29/89) attempted to flee the scene and officers took him to the ground. While on the ground Darrell fought with officer. Several knee strikes were given to Darrell as he would not listen to officer commands and place his hands behind his back. PO Binter used his Electronic Control Device on Darrell to gain control of him. Jessica L. Harris (F/W 06/13/83) interfered with officers multiple times while we were gaining control of Darrell. Upon arrival, I conducted a search of Jessica L Harris FW 06/13/83. She was placed under arrest by Officer Kaye for Disorderly Conduct and Obstructing an Officer. I later transported her to the WAPD for booking.

**STATEMENT OF BARTENDER (Terese N Zunker FW 05/14/85)**

Zunker reported there were no problems inside the bar. She heard a large commotion coming from outside after bar close. She went outside and observed several people yelling and fighting in the roadway. Zunker recognized most of the people as customers who were inside the bar just prior to bar close. Prior to this evening, the only person she knows as a regular customer is Shelly J Harris. Zunker went inside but did not call the police.

**CONTACT STATEMENT (Kimosha L Briggs FB 06/01/85)**

Briggs reported she came to the bar to throw a surprise birthday party for Darrell Harris. He's been sober for one year so they decided to have a celebration. Briggs stated her friend, Jennifer's jacket was stolen inside the bar. Briggs, Darrell and most of their friends went outside because several people left just as they realized her jacket was missing. Brigg's stated Angie Sanchez had Jennifer's coat and gave it back to her. Brigg's stated she knows Sanchez from high school but they don't talk anymore.

A male subject, named Jordan, started arguing with Darrell because he was accusing Jordan of stealing Jennifer's jacket. Jordan and Darrell started fighting in the roadway. Jordan got away from Darrell and left in a white sedan with Sanchez and a few other unknown subjects.

Briggs stated she didn't have any other information on Jordan or the vehicle the subjects left in. Briggs was highly intoxicated and it was difficult to obtain a statement from her.

**INITIAL CALL FOR SERVICE**

On 03/30/13 at approximately 0221 hrs, I responded to Shepards, 8924 W Schlinger Ave, for a report of approximately 15 people fighting in the middle of the road.

**WITNESS STATEMENT**

Upon my arrival, I made contact with witness, Jay A Racsek, M/W 05/28/80. Jay advised, a white four door vehicle was parked on the corner of S 89 St/W Schlinger Ave. An unknown white female, wearing pink clothes, said to the female driver of the white vehicle, "I'll kick your ass" and proceeded to kick the drivers door window. An unknown white male was standing on the north side of W Schlinger Ave, near the parking lot of Shepards, stated that's my car. The unknown white male walked across the street and pushed the female in pink clothes, with two open hands, near the females chest. I asked Jay if he was able to get a clothing description of the white male who pushed the white female in pink. Jay said he was unable to get a good clothing description because everything happened so fast after he pushed her.

Another unknown white male, who was standing on the southside of W Schlinger Ave, came around the white vehicle that was parked on the corner of S 89 St/W Schlinger Ave and pushed the white male who first pushed the female in pink. After the unknown white male pushed the other unknown white male, approximately 8-10 people started punching the two white males. I asked Jay if he could describe anyone invovled in the physical fight. Jay advised a male hispanic who was missing his right arm and a tall asian male were invovled in the fight. **ON SCENE OBSERVATIONS:**

Upon arrival, I made contact with an unknown male and verbally directed him to sit on the curb in front of my squad. I observed Pto Kaye attempt to take a male, later identified as Darrell K Harris, into custody. Darrell became non-compliant and resisted Pto Kaye's verbal commands.

**RESISTING AN OFFICER**

I observed Pto Kaye stabilize Darrell on the ground. Darrell immediately became resistive by flailing on the ground and pushing away from Pto Kaye. Darrell's body became rigid and he attempted to get up off of the ground several times I ran to Pto Kaye's location in the parking lot of Shepherds Bar and grabbed hold of Darrell's right arm. Darrell then went from his knees and elbows to the ground and pulled his hands to his chest.

I felt resistive tension in Darrell's arm as he clasped his hands together underneath himself. I gave Darrell multiple commands to put his hands behind his back. I attempted to pull Darrell's hands apart for approximately ten seconds. I heard a taser deployed and Darrell released his clasped hands and put them out to his side. I immediately brought his right hand behind his back and Pto Kaye handcuffed him.

During the incident with Darrell, I observed Jessica L Harris run up behind Pto Kaye and pull on his shoulder. I directed her to step back and she did not. I pushed her back a few steps and she again walked up behind Pto Kaye and pulled on his shoulder again. I pushed her back again. She stumbled and fell backwards. She put her hands out, which prevented her from rolling onto her back. Jessica was subsequently taken into custody by Pto Kaye.

WAFD was requested and they responded to the scene regarding Darrell's exposure to taser probes. Darrell was treated for the taser exposure. Darrell stated he did not have any other injuries and declined treatment for anything other than the taser exposure.

Based on Darrell fighting with other patrons at Shepherd's Bar, his screaming/yelling outside at 0221 hours, his disregard for Officers' verbal commands, and his attempt to prevent Officers from taking him into custody, Darrell was subsequently taken into custody for Disorderly Conduct and Resisting an Officer. Darrell was conveyed back to WAPD for booking.
