**RESOLUTION TO AMEND THE EXISTING CONTRACT WITH BLUE RIBBON
ORGANICS FOR THE CONTINUATION OF YARD WASTE MANAGEMENT
SERVICES**

WHEREAS, in 2016 and 2021 the Finance Department advertised, received, and evaluated requests for proposal to provide yard waste management services for the Department of Public Works; and,

WHEREAS, in both 2016 and 2021, the proposal for yard waste management services from Blue Ribbon Organics was selected and awarded; and,

WHEREAS, Blue Ribbon Organics has requested to extend the current contract, including amended pricing due to increased costs for processing yard waste materials; and,

WHEREAS, Blue Ribbon Organics and the Department of Public Works have negotiated a 3 percent pricing increase for yard waste management services for each year through 2028; and,

WHEREAS, The Common Council deems it to be in the best interests of the City of West Allis that the amendment requested by Blue Ribbon Organics be accepted.

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the proposed amendment submitted on August 19, 2025 by Blue Ribbon Organics for removal and disposal of leaves & garden debris, branches, and brush for the period and pricing specified in the attached contract is approved; and, be it

BE IT FURTHER RESOLVED that both parties may mutually agree to renew this contract for an additional three years and, be it

BE IT FURTHER RESOLVED that the Department of Public Works Director is authorized to enter into a contract with Blue Ribbon Organics for yard waste management services; and, be it

BE IT FURTHER RESOLVED that funding for this service is budgeted in account 550-4233-535-4109 Solid Waste Dumping Fees.
