

**CITY OF WEST ALLIS
RESOLUTION R-2026-3745**

RESOLUTION TO ACCEPT THE PROPOSALS OF GRAYBAR ELECTRIC, HEIN ELECTRIC, AND CRESENT ELECTRIC TO FURNISH AND DELIVER FUSES, FUSE HOLDERS, CONNECTORS, WIRE, AND CABLE FOR A TOTAL OF \$91,773.02.

WHEREAS, the Inventory Division has received proposals through a competitive bid process to furnish and deliver electrical supplies for the Street Light Conversion Project for the Public Works Department of the City of West Allis, and the proposals were reasonable; and,

WHEREAS, the Common Council deems it to be in the best interest of the City of West Allis that the proposal submitted by Hein Electric to furnish fuses, fuse holders and multi-tap connectors, 40 LED Lamps, and 20,000 feet of HDPE Conduit for a total of \$21,305.20; Graybar Electric to furnish 9,500 feet of THHN wire for a total of \$3,007.51; and Cresent Electric to furnish 20,000 feet of underground power cable for a total of \$67,460.31 be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the proposals submitted by Hein Electric, Graybar Electric, and Cresent Electric budgeted for 2026 Project # M2620M, Street Light Conversion Project, with funding provided by Account Number 354-6051-517.31-02, Capital Projects Fund, Project Activities, Other, be accepted.

BE IT FURTHER RESOLVED that the Inventory Division is authorized to enter into contracts for the aforementioned material.




