The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of August 2009

Police report incidents involving licensed businesses:

Tavern reports:

Case 09-006938, 08/02/09 at 1724hrs. GW's Jaws, 9033 W National Ave.

On the above date and time officers were called to an argument in the parking lot at 9033 W National Ave. A male and female were arguing because the male was trying to get the female to leave the tavern after she caused a disturbance. The female was intoxicated and was using unacceptable language in the tavern where two younger children were eating with their parents. The woman also claimed she was choked, possibly by the children's father. Officers were concerned that the woman may have been over served as the bartender stated that the woman was drinking in the bar and was loud and profane.

Case 09-007146, 08/08/09 at 0100hrs. Barneck's Tavern, 7411 W Becher St.

On the above date and time officers responded to a 911 hang up call at Barneck's Tavern. Through investigation it was learned that an intoxicated female was involved in a fight with another patron and then broke several glasses and bottles along with tipping over a table. The female was arrested for Disorderly Conduct.

Call 09-037589, 08/15/09 at 0121hrs. Smokin Joe's, 6139 W Beloit Rd.

On the above date and time officers responded to a call in the 2100 Block of S 62 St in regards to a party intoxicated and passed out on the lawn there. It was learned the passed out party was drinking with friends at Smokin Joe's. Party may have been over served.

Call 09-037592, 08/15/09 at 0139hrs. Flapper's Tavern, 7527 W Becher St.

On the above date and time officers were called by the bartender in regards to patrons of the tavern fighting outside. The fight erupted over a disagreement during a game of pool. Nothing was damaged in the tavern and no one wished to pursue charges so all parties were sent on their way.

Case 09-007753, 08/25/09 at 0205hrs. Smokin Joe's, 6139 W Beloit Rd.

On the above date and time an officer observed a male party urinating on a fence in the 6100 block of W. Beloit Rd. The party who was intoxicated and underage stated he just came from Smokin Joe's where he had been drinking. The bartender admitted that the party officers had in custody was in his bar and drinking. The bartender and the male were both issued citations for alcohol offenses.

Case 09-007753, 08/26/09 at 0010hrs. Smokin Joe's, 6139 W Beloit Rd.

On the above date and time officers responded to a call from the bartender at Smokin Joe's in regards to a female who scratched and punched him. The bartender stated that the woman was attempting to dance on the bar. The complainant had to pull her off the bar and at that time she scratched his neck causing him to bleed. He then attempted to cut her off by taking her drink and she punched him in the face. The female was arrested for Battery and the male she was with was also arrested for Carrying a Concealed Weapon (knife with 4" blade),

Case 09-007956, 08/30/09 at 0142hrs. Painted Parrot, 8028 W National Ave.

On the above date and time officer responded to a call of a large fight in the bar which had progressed out into the parking lot. Five parties were arrested for Disorderly Conduct for the fight. During the investigation it was learned that one of the parties involved was underage and had been drinking in the tavern. The party was cited along with the bartender for alcohol related offenses.

Case 09-007957, 08/30/09 at 0150hrs. Smokin Joe's, 66139 W Beloit Rd

On the above date and time officers took a complaint from the bartender at Smokin Joe's in regards to his vehicle being damage in the lot. Through investigation it was learned that there was a minor altercation earlier in the bar between the bartender and a male party. When the bartender left for the night he noticed the damage to his vehicle.
