RESOLUTION R-2026-5072**

**RESOLUTION TO AUTHORIZE THE TRANSFER OF \$39,453.96 FROM THE
STORM WATER SALARY ACCOUNT TO THE STORM WATER CAPITAL ITEMS
ACCOUNT FOR THE PURCHASE OF ONE SLOPE MOWER**

WHEREAS, the Public Works Forestry Division is responsible for mowing over 12 acres of drainage ditches, storm water retention areas, and sloped terrain throughout the city; and,

WHEREAS, in the fall of 2025 and spring of 2026 multiple rental suppliers of mowing equipment were no longer providing rental services; and,

WHEREAS, it was determined to evaluate purchasing a slope mower to allow for the mowing of these areas more frequently and the ability to address other sloped areas of exceeding vegetation growth within the city; and,

WHEREAS, funding for the purchase of this equipment was not identified for the 2026 fiscal year and additional funds are needed for the purchase of the selected slope mower, and;

WHEREAS, consulting with the Finance Department, it was determined funds from the Storm Sewer Salary Account be used.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the Department of Public Works is authorized to transfer funds of \$39,453.96 from the Storm Water Salary Account 540-1801-538.11-01 Regular Employees / Salary & Wages to 540-1801-538.70-03 Capital Items.

BE IT FURTHER RESOLVED that City Officers are authorized and directed to take appropriate action to implement said actions.

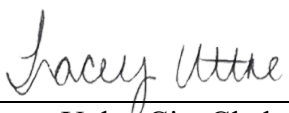

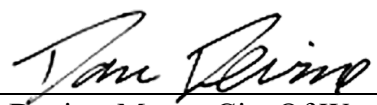
