Appearance by Mark S. Anderson. Mr. Anderson informed the Committee he would like to relocate his business to West Allis at 7905 W. Lincoln Ave. Ald. Czaplewski stated a Public Hearing would be required to exceed the quota on a Combination Class A Liquor License. A discussion ensued regarding whether other catering businesses held licenses, and the necessity of it. Mr. Anderson informed the Committee that the State Department of Revenue requires a caterer to hold a liquor license if they offer alcohol with their service. The question arose if any stipulations could be written into a Special Use Permit. Ald. Weigel raised concern about this location becoming a liquor store if the catering business would leave. Attorney Post stated once the license was issued it could be transferred to another location and the stipulations would no longer stand. This item was held pending further research, and scheduled for July's meeting.
