D. MATTERS FOR DISCUSSION/ACTION

Pursuant to Wis. Stat. 7.52, the West Allis Board of Absentee Ballot Canvassers shall publicly convene to count all absentee ballots that are received by the city clerk at West Allis City Hall by 8:00 p.m. on election day. Polling places will not accept completed absentee ballots for counting; all completed absentee ballots must be in delivered to City Hall before 8:00 p.m. to be counted. The board will adjourn at 8:00 p.m., or at such time that all absentee ballots have been canvassed, whichever is later.

Any member of the public has the same right of access to a meeting of the board of absentee ballot canvassers that the individual would have under Wis. Stat. 7.41 to observe the proceedings at a polling place. The board of absentee ballot canvassers may order the removal of any individual exercising the right to observe the proceedings if the individual disrupts the meeting.

All meetings of the West Allis Board of Absentee Ballot Canvassers are public meetings. In order for the general public to make comments at the committee meetings, the individual(s) must be scheduled (as an appearance) with the chair of the committee or the appropriate staff contact; otherwise, the meeting of the committee is a working session for the committee itself, and discussion by those in attendance is limited to committee members, the mayor, other alderpersons, staff and others that may be a party to the matter being discussed.

No action will be taken by any governmental body at the above-stated meeting other than the governmental body specifically referred to above in this notice.
