I request that this issue be put on January of 2022 so that I can have a discussion with the Counsil.

I believe that our city can become the forerunner of tranforming the observance of this great day in a manner that will benefit all of the residents of our city. Once this is accomplished, than our neighboring cities and villages can witness a much better celebortory enviorment, which they in turn can also implement, which would give a much needed relief to any police department that may be burdened with extra calls for illeagel usage.

The followling list are ideas in which I hope can be established in a manner that would transform our observance to a more practical and peacefull manner for our citzenery.

My wife and I have only lived in West Allis for a few years. So any of the current happenings during this time are of course unknown.

I understand that those who use the fireworks don't care about whether these products are illeagal or not. They just want to enjoy setting them off.

My first intention is to continue to determine by way of contacting the fireworks makers to find out what their perception is about their products.

This premise is where the city can step in and take the lead on reducing or stopping those products from being obtained. This of course is a matter for the police department to handle, with, of course direction from the city attorney's office.

Even though our municpal neighbor, West Milwaukee, has the vendors at Pick and Save and Menards; our city can still work towards a means to ensure that our citzens understand what is expected for a more peaceful observance.

Of course, since I enjoy fireworks as well, there are other ways to allow those who continuely get them. The city can designate a number of areas in the city for them to obtain permits, as is directed in the state statues. Along with this, there should be incentives for them to be willing to go this direction in their celebartaion.

I have been told that our city parks don't allow for this type of activity. I believe that an exception can be made.

Of course, to go this route, the city would need an system in place to ensure that this new way of

In addition, the neighborhood assoc. can begin to reachout to the citzenry this Spring and early Summer to inform and obtain understanding of the benefits of my suggestions.
