ORDINANCE O-2022-0032**

**ORDINANCE TO DISSOLVE MUNICIPAL BOARD OF ABSENTEE BALLOT
CANVASSERS**

REPEALING SECTIONS 2.08(4) AND 2.23

WHEREAS, in O-2020-0039, the city created the municipal board of absentee ballot canvassers and adopted the procedure under Wis. Stat. 7.52; and

WHEREAS, the council may by similar action rescind that decision pursuant to Wis. Stat. 7.52(9), so that absentee ballots at all elections shall be canvassed as provided in Wis. Stat. 6.88;

NOW THEREFORE, the common council of the City of West Allis do ordain as follows:

SECTION 1: **AMENDMENT** “2.08 Elections And Officials” of the City Of West Allis Municipal Code is hereby *amended* as follows:

A M E N D M E N T

2.08 Elections And Officials

1. The city clerk may select alternate officials in a number sufficient to maintain adequate staffing of polling places on election day.
2. The city clerk may select 2 or more sets of election officials to work at different times on election day and may establish different working hours for different officials assigned to the same polling place.
3. The city clerk may appoint 3, 5, or 7 inspectors to each polling place and may appoint an additional inspector to serve as a greeter. The city clerk may appoint additional inspectors in compliance with Wis. Stat. 7.30.
4. ~~In lieu of canvassing absentee ballots at polling places, the board of absentee ballot canvassers shall, at each election held in the city and in compliance with Wis. Stat. 7.52, canvass all absentee ballots received by the city clerk by 8 p.m. on election day.~~

SECTION 2: **AMENDMENT** “2.23 Board Of Absentee Ballot Canvassers” of the City Of West Allis Municipal Code is hereby *amended* as follows:

~~Composition. Members of the board of absentee ballot canvassers shall be appointed pursuant to Wis. Stat. 7.53(2m)(b). Duties. The board of absentee ballot canvassers shall perform all duties assigned by law.~~

SECTION 3: EFFECTIVE DATE This Ordinance shall be in full force and effect on and after the required approval and publication according to law.

SECTION 4: FEE SCHEDULE UPDATE The clerk shall update the Fee Schedule to remove any references to the board of absentee ballot canvassers.
