The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of December 2021:

## **INCIDENT REPORTS:**

#### Officer Best Reports...

On 12/05/2021 at 0104 hours, Officers were dispatched to The Network Tavern located at 9541 W Cleveland Ave for a report of shots fired. I spoke with Jacob M. Silber, who stated two separate groups entered the bar arguing. The groups exited the bar and Jacob heard three gunshots. Both groups fled the area southbound prior to police arrival. There are two suspect descriptions at this time. One is a light skinned male with braids and a red hoodie who is believed to have fire the shots. Another suspect is a skinny, Hispanic or light skinned black male, in his mid 20's, approximately 5'8", 140-150lbs, wearing a dark grey hoodie. Witness statements indicate the male in the dark grey hoodie was physically assaulted. Then the male in the red hoodie fire shots at him. Several blood drops were located leading from the entrance around the western wall of the bar. These blood drops were not consistent with a gunshot wound. No shell casings were located, however, a witness stated he observed the shooter fire the gun from inside of his front sweatshirt pocket. At approximately 0200 hours, area hospitals were checked for any patients that came in reporting a gunshot wound but no one was located.

Strozinsky who said Lynn texted him saying she was going to kill herself. Daniel said Lynn was intoxicated at a bar in Milwaukee. Daniel took Lynn home and she began ripping stitches out of her arm from cutting herself two days prior. Lynn was located at Amann's Bar, 8824 W. Becher St. Lynn refused to identify herself and resisted officers. During the resistive episode Lynn kicked officers. Lynn was placed under a chapter 51 and taken to AWAMC for medical clearance. Lynn was later transported to CJF. Her court date is 12/23/21.
