## CITY OF WEST ALLIS RESOLUTION R-2021-0671

## RESOLUTION FOR A SPECIAL USE PERMIT FOR AN AUTOMOBILE CONVENIENCE STORE AND GAS STATION USE TO BE LOCATED AT 2904 S. 84TH ST.

**WHEREAS,** Gurinder Nagra, d/b/a State Fair Petro Mart Inc., filed with the City Clerk an application for a Special Use Permit, pursuant to Sec., 12.42(2) and Sec. 12.16 of the Revised Municipal Code, to establish an automobile convenience store and gas station use to be located at 2904 S. 84th St.; and,

**WHEREAS,** after due notice, a public hearing was held by the Common Council on November 16, 2021, at 7:00 p.m., in the Common Council Chambers to consider the application; and,

**WHEREAS**, the Common Council, having carefully considered the evidence presented at the public hearing and the following pertinent facts noted:

1. The applicant, Gurinder Nagra, d/b/a State Fair Petro Mart, Inc, will operate the proposed use at 2904 S. 84 St. The applicant has an offer to purchase the property at 2904 S. 84 St. The subject property is described as follows:

All the land of the owner being located in the Southeast ¼ of Section 9, Township 6 North, Range 21 East and Southeast ¼ of Section 34, Township 7 North, Range 21 East City of West Allis, Milwaukee County, Wisconsin, described as follows:

Beginning at the Northwest corner of Lot 1 in Block 1 of the Roth Builder's Inc. Subdivision; thence Northerly, 117.89 feet, along the East right-of-way line of South 84th Street to the South right-of-way line of West Beloit Road; thence Northeasterly, 90.46 feet, along the said South right-of-way line of West Beloit Road; thence Southeasterly, 220.00 feet; thence Southwesterly, 62.10 feet, to the Northeast corner of said Lot 1; thence Westerly, 120.00 feet, to the said East right-of-way line of South 84th Street and Point of Beginning of this description.

Tax Key No. 516-9988-001

Said land being located at 2904 S. 84th St.

- 2. The 2904 S. 84 St. property is zoned C-3, Community Commercial District, under the Zoning Ordinance of the City of West Allis, which permits automobile convenience store and gas station uses as a special use, pursuant to Sec. 12.42(2) and Sec. 12.16 of the Revised Municipal Code.
- 3. The subject property is located along the south side of W. Beloit Rd. and east of S. 84 St., which is zoned for commercial purposes. Properties to the east are zoned commercial and developed for residential use. Properties to the west are zoned multi-family and developed for high density residential. Properties to the south are zoned and developed for residential use. Properties to the north are zoned and developed for commercial use.
- 4. The property will provide off-street parking for employees and customers. The property will also include bicycle and pedestrian accommodations.

**NOW THEREFORE,**BE IT RESOLVED by the Common Council of the City of West Allis that the application of Gurinder Nagra, d/b/a State Fair Petro Mart, Inc., to establish an automobile convenience store and gas station, located at 2904 S. 84 St., be, and is hereby granted on the following grounds:

That the establishment, maintenance, and operation of the proposed use, with the imposition of certain conditions hereinafter set forth, reasonably satisfies the standards set forth in Section 12.16 of the Revised Municipal Code, so as to permit the issuance of a special use permit as therein provided.

BE IT FURTHER RESOLVED that said special use permit is granted subject to the following conditions:

Site, Landscaping, Screening and Architectural Plans. The grant of this special use permit is subject to and conditioned upon the site, landscape, screening, and architectural plans approved on October 27, 2021, by the City of West Allis Plan Commission as provided in Sec. 12.13 of the Revised Municipal Code of the City of West Allis. No alteration or modification of the approved plan shall be permitted without approval by the Plan Commission.

- 1. Building Plans and Fire Codes. The grant of this special use is subject to building plans being submitted to and approved by the Department of Building Inspections and Neighborhood Services and by the Fire Department.
- 2. Business Operations. The grant of this special use is conditioned upon the following:
- A. Excessive odors from cooking on premises shall be controlled within limits of current technology.
- B. Excessive noise and vibrations shall not emanate from the building.
- C. All exterior doors and windows being kept closed after daytime hours to prevent excess noise from entering the adjacent neighborhood.
- D. Exterior pest control shall be contracted on a monthly basis and/or in accordance with the City of West Allis Health department.
- E. Licensed operation. Necessary licenses being obtained in conjunction with the proposed business operations.
- 3. Hours of Operation. The proposed automobile convenience store and gas station has indicated hours of operation to be 5:00 AM to 10:00 PM Monday through Saturday and 6:00 AM to 10:00 PM Sunday.
- 4. Off-Street Parking. Thirteen (13) off-street parking spaces are required for the proposed use. A total of seventeen (17) will be provided on site including one ADA space.
- 5. Litter. Employees shall inspect the area and immediate vicinity and pick up litter on a daily basis. Refuse, recyclables, and other waste materials will be enclosed in accordance with the approved site plan.
- 6. Marketing Displays. The use of pennants, special lighting, flags, streamers or other signage typically temporary in nature, hanging, floating or attached to a structure or vehicle shall not be permitted.
- 7. Signage. Signage for the overall property shall be in accordance with the City of West Allis Signage Ordinance Section 13.21 of the Revised Municipal Code; window signage shall not exceed twenty (20) percent of each window's area and be installed on the inside of the glass.
- 8. Deliveries and Refuse Collection. All refuse to be provided by a commercial hauler. All refuse, recyclables and other waste material shall be screened from view within an enclosure

approved by the Department of Development. All tenants of the property will be required to abide by the City of West Allis health/public nuisance rules per Chapter 7 of the Revised Municipal Code. Because there are residents that live within the residential neighborhood adjacent to the site, delivery operations and refuse pick up shall only be permitted during daytime hours. These functions shall not be permitted between the hours of 10:00 p.m. and 7:00 a.m.

- 9. Intercoms and Loudspeakers. If gas pump loudspeakers are used, audio volume must be contained to the property and levels must be adjustable to prevent nuisance. The use of other outdoor pagers, intercoms, or loudspeakers shall not be permitted on site.
- 10. Outdoor Lighting. The grant of this special use is subject to all lighting fixtures being orientated downward and/or shielded in such a manner that no light splays from the property boundaries.
- 11. Noxious Odors, Etc. The use shall not emit foul, offensive, noisome, noxisome, noxious or disagreeable odors, gases, or effluvia into the air. Mechanical systems shall be maintained to efficiently remove noxious odors.
- 12. Pollution. The use shall not cause any noxious or unwholesome liquid or substance or any dirt, mud, sand, gravel, or stone refuse or other materials to be deposited upon any public right of way or flow into any sanitary sewer, storm sewer, or water supply system, or onto adjacent properties.
- 13. Expiration of Special Use Permit. Any special use approved by the Common Council shall lapse and become null and void one (1) year from and after that approval if the use has not commenced, construction is not underway, or the owner has not obtained a valid building permit. An extension of these time limitations may be granted without a public hearing by the Common Council by resolution reauthorizing the special use in accordance with the following criteria:
- A. The applicant requesting the extension shall complete a planning application available from the Department of Development and shall submit a \$250.00 extension fee.
- B. A written explanation for the extension of time shall accompany the planning application along with a timeline/schedule for obtaining necessary permits, zoning, state and municipal approvals and a target date for construction start;
- C. The request for extension shall be submitted within sixty (60) days of the expiration of the special use permit;
- D. The extension, if granted, shall be valid for a period of six (6) months. If no building permit has been issued and construction has not commenced within six (6) months from and after the extension has been granted, the special use shall become null and void.
- 14. Miscellaneous.

- A. Applicants are advised that the foregoing conditions are reasonably necessary to protect the public interest and to secure compliance with the standards and requirements specified in Sec. 12.16 of the Revised Municipal Code; that the issuance of the special use is expressly subject to compliance with said conditions.
- B. The use, as granted herein, is subject to applicants' compliance with all other state and local laws and regulations which may be applicable to the proposed use of the real estate in question.
- C. The special use, as granted herein, shall run with the land and benefit and restrict all future owners and occupants of the property, unless the use shall lapse or be terminated and the use will not be altered or extended (including structural alterations and/or additions) without the approval of the Common Council, following public hearing, all as provided in Sec. 12.16 of the Revised Municipal Code.
- 15. Lapse. If the applicant does not meet all of the terms and conditions set forth in this grant of a special use within one year of the granting thereof, then the Special Use Permit shall lapse and become null and void and the applicant shall forfeit any right to use the property as conferred by the Special Use Permit. The failure of the applicant to meet the terms and conditions of the Special Use Permit shall subject the permit to being declared void by the Common Council after notice to the applicant and a hearing before the Safety and Development Committee. Upon a finding and recommendation by the Committee to the Common Council on the matter, the applicant and/or any interested person may make comments regarding the matter to the Common Council prior to the Common Council's next regular meeting following the recommendation. Upon the Common Council's finding that the Special Use Permit has lapsed and become void, the applicant shall cease all operations at the property.
- 16. Termination of Special Use. If the person or entity granted the special use violates, allows or suffers the violation of the ordinances of the City of West Allis, the State of Wisconsin or the United States on the premises covered by the special use, then the special use may be terminated.
- 17. Acknowledgement. That the applicants sign an acknowledgment that he has received these terms and conditions and will abide by them.

The undersigned applicant agrees to the terms and conditions and has agreed that the grant of the Special Use Permit is conditioned on meeting the terms and conditions of this resolution.
