RESOLUTION R-2022-0189**

**RESOLUTION TO AUTHORIZE THE PURCHASE OF SCALE COMPUTING
HYPERCONVERGED SOLUTION AND 3 YEARS OF SUPPORT FROM CDW-G
FOR \$54,216.96 FROM ACCOUNT 261-8501-517.70-08 TO UPGRADE THE POLICE
DEPARTMENT'S PRIMARY SERVER COMPUTING INFRASTRUCTURE**

WHEREAS, The City of West Allis has standardized on using Scale Computing Hyperconverged Infrastructure as the foundation for Server Infrastructure supporting the software and storage used by all departments; and

WHEREAS, In 2021 we upgraded the Scale system at City Hall, as it was purchased one year before the similar unit at the Police Department. That upgrade went as expected, and now it is time to do the same for the unit at the Police Station; and

WHEREAS, Heightening the importance of this upgrade is the fact that this same aging system hosts the ProPhoenix application for three neighboring communities (West Milwaukee, South Milwaukee and Cudahy). West Allis is contractually obligated to provide a level of service back to these communities, and that would be compromised if we do not upgrade this Scale system. The account that is being used to fund this upgrade is the same account that contains the revenues we receive from these agencies; and

WHEREAS, the Information Technology Department has been notified that existing hardware will no longer supported by May 2022 as it has officially reached end of life state from the manufacturer and support vendors; and

WHEREAS, this project was submitted as a 2022 Capital Improvement Project and was vetted and approved by that working group; and

WHEREAS, CDW-G offered the lowest licensing pricing available for this upgrade; and

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the quote dated February 2nd, 2022 for providing Scale Computing Hardware and 3 years of support for the sum of \$54, 216.96 be and is hereby accepted. The account where this will be charged to is account # 261-8501-517.70-08.

BE IT FURTHER RESOLVED, that the Finance Department be and is hereby authorized to enter into a contract for the aforesaid services.
