RESOLUTION TO ADOPT THE SCHEDULE OF PROPOSED ASSESSMENTS FOR IMPROVEMENT OF S. 91ST ST. FROM W. ARTHUR PL. TO W. HARRISON AVE., W. VIGO TERR. FROM S. 99TH ST. TO EAST OF S. 99TH ST., W. HAYES AVE. FROM W. GREENLINKS DR. TO EAST END AND W. ORCHARD ST. FROM S. 93RD ST. TO S. 95TH ST. BY MINOR ASPHALT RESURFACING
