**RESOLUTION RELATIVE TO ACCEPTING THE PROPOSALS OF CRESCENT  
ELECTRIC, GEXPRO SUPPLY, AND NEHER ELECTRIC FOR FURNISHING AND  
DELIVERING FUSES, FUSE HOLDERS, CONNECTORS, WIRE, CABLE, AND  
LUMINAIRES FOR A TOTAL SUM OF \$124,085.83**

**WHEREAS,** The Purchasing Division has reported that it has received proposals through a competitive bid process for furnishing and delivering electrical supplies for the Street Light Conversion Project, for the Public Works Department of the City of West Allis, and that the proposal was reasonable; and,

**WHEREAS,** The Common Council deems it to be in the best interest of the City of West Allis that the proposal submitted by GexPro Electric Supply for furnishing 400 fuses, and 400 fuse holders for \$2,972.00, Crescent Electric for furnishing 270 assorted multi-tap connectors, wire and direct burial cable for \$40,241.33, and Neher Electric for furnishing 375 luminaires and shorting caps, for \$80,872.50 be accepted.

**NOW THEREFORE,** BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the proposals submitted by GexPro Electric Supply (\$2,972.00), Crescent Electric (\$40,241.33), and Neher Electric (\$80,872.50) budgeted for 2022 Project # M2220M, Street Light Conversion Project with funding provided by, Account Number: 354-6051-517.31-02, Capital Projects Fund, Project Activities, Other, be and is hereby accepted.

BE IT FURTHER RESOLVED, that the Purchasing Department be and is hereby authorized to enter into contracts for the aforementioned material.
