Fire Protection Fee - Administration and Finance; PFC - Ranked #1				
↔ Levy limit must be reduced by the levy cost of service in 2013. ↑ Fees are assessed to <u>all properties</u> . (reduction of costs to current levy payers) ↑ Further increases to the services are outside of the levy limit. ↔ Governing bodies determine calculation, variety of options.				
Joint Fire Department- Administration and Finance; PFC - Ranked #2				
↓ Expenditures for fire services are higher per capita than many other possible partners ↑ Increases are outside the levy limit ↓ Levy limit relief does not come until the year following the first year of operation ↔ Cannot exceed the change in CPI, plus 2% (12 months before Sept 30 of the levy year) ↔ Each governing body must approve the increase				
FEMA Safer Grant – Administration and Finance; PFC - Ranked #3				
↑ Supports hiring new, additional firefighters, rehire laid off firefighters, or to retain firefighters facing layoff. ↑ No cost share or maintenance of effort. ↑ No maximum award amounts. ↓ Performance Period is 36 months (must maintain level of staffing for 3 years, no reductions)				
Cut Programs - All Standing Committees, PFC, and Library Board - Ranked #5				
↓ City of West Allis is a full-service City with residents who have high expectations for quality, timely service. ↔ Staff has done an outstanding job of helping out/cross training to minimize the impact on service delivery despite the position cuts. ↑ Not all our staff are engaged in or support statutory services. Example: Plowing Alleys, Dental Services, Book Delivery, etc.
