On 09/04/17, your dog, Bella, was involved in an incident and you were issued a City of West Allis Dangerous Dog Order. You are required to comply with city ordinance 7.126(6), which includes proof of liability insurance, proof of spay/ neuter compliance, a \$75.00 payment for registration of the dog at the West Allis Police Department, and a color photograph of the dog. You must also comply with the leash and muzzle requirements, confinement requirements, and signage requirements. Attached you will find a copy of city ordinance 7.126(6).

You have 30 days from the date of the incident to appeal this order in writing to the City Administrative Review Board. If you have chosen to remove the dog from the City of West Allis, you must provide information as to where the dog is now located, or proof of euthanasia. Failure to comply with the order can result in up to a \$1,000.00 fine per day of non-compliance.

**NARRATIVE****INITIAL CALL**

On 09/04/17 at approx. 1647 hrs., officers were dispatched to 2101 S. 88 St., for a dog vs dog bite that occurred earlier in the day. Upon arrival, I made contact with Jennifer K. Heck, F/W 04/06/79, and Stephanie J. Lacasse, F/W 01/30/82.

**STATEMENT OF JENNIFER K. HECK**

Jennifer said her dog, Jax, was attacked by two other dogs while her friend, Stephanie was walking him. She said it occurred some time between 1030 hrs and 1100 hrs. Jax had a puncture in the upper right rear leg, and was limping around.

Jax is a male three year old english setter. He is white with tan spots. His rabies vaccination tag is #7350. I asked Jennifer if she wanted the owner of the dog to receive a citation. She said she did not want that and just wanted it documented.

**STATEMENT OF STEPHANIE J. LACASSE**

After speaking with Jennifer I spoke with Stephanie. She said she was walking Jax at approx. 1030 hrs. While walking on the west sidewalk in front of 2153 S. 88 St., she heard two dogs barking and running toward her, from behind. Moments later, behind the dogs, was a teenage male who was trying to get the dogs back. The two dogs looked like they were biting Jax, until the male was able to get both

dogs back inside the residence. She ultimately walked toward Jennifer's residence to return Jax.

Jennifer said the incident took place for less than 30 seconds. She did not know which dog caused the puncture in the back leg. She said both dogs were shorter, but stockier. She did not know what kind of dogs they were, but thought possibly a pitbull mix. She said she did not see them with leashes.

**STATEMENT OF MICHAEL L. ALBRECHT**

After speaking with Jennifer, I responded to the incident address, 2153 S. 88 St. I made contact with the owner, Michael L. Albrecht, M/W 08/30/95, and his friend, Tyler D. Day, M/W 08/16/99. Michael said the two dogs involved in the altercation belonged to him. He did not witness the incident, but Tyler did.

Michael said Bella is a two year old female blue heeler german shepherd mix. She is black with some tan. The second dog, Lola, is a one year old female pitbull bullmastiff mix. She is tan in color.

Michael said the rabies vaccinations are up to date and he would give me the date/vet information of the rabies shots for the dogs.

**STATEMENT OF TYLER D. DAY**

After speaking with Michael, I spoke with Tyler. He said he was with the two dogs before they exited the residence. They were near the back door when someone opened the door, and the dogs went outside. He saw the dogs playing on their way toward the front, and heard barking. He immediately ran to the front to see them jumping on another dog. He was able to get both dogs inside the house, and said the incident did not take more than 25 seconds.

Tyler did not know which dog bit Jax. I asked Michael and Tyler which dog was aggressive with other dogs. They said Bella was the protective one, and believed she may have been the one to bite Jax.

**DANGEROUS DOG FORM**

Michael was issued the Dangerous Dog Form. The original copy was ultimately sent to the Department of Health.

**CASE DISPOSITION**

Two dogs (Bella and Lola) were able to get out of a residence and they rushed toward another dog (Jax) being walked. Jax had one puncture mark on his rear leg.

Michael Albrecht was issued a Dangerous Dog form. Jennifer Heck, the owner of Jax, did not want a citation issued.




