RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR OF THE ECONOMIC DEVELOPMENT PROGRAM TO AMEND A LANDSCAPE DESIGN/ARCHITECTURAL SERVICES CONTRACT WITH PARKITECTURE PLANNING, LLC, FOR CONCEPTUAL PLANS AND CONSTRUCTION DOCUMENTS FOR A FOUR SEASON SHELTER AT LIBERTY HEIGHTS PARK, IN AN AMOUNT NOT TO EXCEED AN ADDITIONAL \$65,080

WHEREAS, the City has interest in creating an inclusive park within the city; and,

WHEREAS, the City entered into a contract with Parkitecture Planning, LLC, for site selection and design of an inclusive park through Resolution R-2022-0310 dated April 19, 2022, in an amount not to exceed \$13,160.

WHEREAS, the Economic Development Program recommends amending the existing contract with Parkitecture Planning, LLC, in an amount not to exceed an additional \$65,080, in order to assist the City with site selection and design of an inclusive park.

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis as follows:

- 1. That the Executive Director of the Economic Development Program, or his designee, is authorized to enter into an amended contract with Parkitecture Planning, LLC for conceptual plans and construction documents for a four season shelter at Liberty Heights Park, in an amount not to exceed an additional \$65,080
- 2. That additional \$65,080 be and is hereby appropriated from the 2022 Community Development Block Grant (CDBG) Admin Project (C22101) funds.
- 3. That the City Attorney be and is hereby authorized to make such non-substantive changes, modifications, additions and deletions to and from the various provisions of the Contract, including any and all attachments, exhibits, addendums and amendments, as may be necessary and proper to correct inconsistencies, eliminate ambiguity and otherwise clarify and supplement said provisions to preserve and maintain the general intent thereof, and to prepare and deliver such other and further documents as may be reasonably necessary to complete the transactions contemplated therein.
