12/21/22	1	 Applicant requested has obtained sponsor - Application to be initiated by the Common Council by introducing a resolution declaring that the "public interest requires it." - 66.1003(4)(a) Applicant requested - does not have sponsor - then fee via Planning Application (\$500 fee and project description). 		
12/21- 12/22	2	Planning Office - Preparation of Document Package includes: A basic area map, a list of property owners of abutters - per WI §66.1003(2), upload circulate vacation request to City staff via OpenGov, Verify if 66.1003(8) applies - additional State or RR agency notice if within ¼ mile of State highway or if there is RR crossing involved, submit the request to Engineering Department to begin preparation of the y-drawing, also place application on next Technical Review and Plan Commission agenda for consideration.		
12/21-22	3	Notify Engineering Department to prepare official map of right-of-way vacation area (called a "Y"-drawing) – this is needed for attachment to the recorded document		
12/21- 1/3	4	Prepare two resolutions per 66.1003(4) for Common Council action: 1) Notice of Hearing (this resolution seeks Council authorization to proceed, or not) 2) Discontinuance Resolution (this resolution for final action – gets recorded)		
1/10/23	4	Common Council meeting to introduce discontinuance resolution: 1) Notice of Hearing		
1/11/23	5	Technical Staff Review meeting		
1/11/23	6	e-Filing (via Simplifile account) of Lis Pendens with Milwaukee County Register of Deeds per Sec. 840.10. A lis pendens containing the names of the parties, the object of the action and a description of the land in that county affected thereby. You will need cover sheet for filing – same date as introduction of Council Resolution/or a few days before.		
1/11/23	7	Serve Notice of Hearing to all owners of frontage of lots and land abutting, in accordance with Sec 66.1003(4)(b), Wis. Stats.– at least one week before deadline, if possible. (Certified, return receipt requested w/Affidavit of Service). The LAST DAY to serve or mail notices to abutting properties (30 days prior to Hearing). Just remember that for the abutting property owners, they need to be notified by "certified mail". You can put all the names on one affidavit of mailing.		
1/11/23	8	Schedule Public Hearing for 3/7/23 must be scheduled no less than 40 days from introduction. So, 40 day minimum in this case is no sooner than 2/21/23.		
1/25/23	9	Plan Commission meeting date		
2/10/23	10	1st Publication in NOW of Notice of Hearing (Our deadline w/ Clerks Office to do this is 8/12/20)		
2/17/23	10	2 nd Publication in NOW of Notice of Hearing		
2/24/23	10	3 rd Publication in NOW of Notice of Hearing (7 days prior to Hearing date)		
3/7/23	11	Common Council Hearing at 7:00 pm in Council Chambers (not less than 40 days from introduction of Resolution) Adoption of Discontinuance Resolution		
Within 30 days of adoption	12	e-Record Vacation Resolution & Map with MKE Co. (via Simplifile account). Need a cover sheet for e-filing.
