RESOLUTION AUTHORIZING THE MANAGER OF PLANNING AND ZONING TO ENTER INTO A PROFESSIONAL SERVICES AGREEMENT WITH COMMUNITY PLANNING AND DEVELOPMENT ADVISORS, LLC.

WHEREAS, the Community Development Block Grant (CDBG) program utilizes a reporting system referred to as the IDIS system; and,

WHEREAS, with new staff involved in the CDBG program, contracting for administrative assistance and specialized training conducted in West Allis will enhance staff skills to monitor the West Allis CDBG program and to report the financial and activity performance accurately, assistance in finalizing Consolidate Plan and Annual Action Plans; and,

WHEREAS, the Manager of Planning and Zoning has received a proposal to enter into a professional services agreement with a consultant Community Planning and Development Advisors, LLC. (CPDA), and,

WHEREAS, the Economic Development Office and Finance Departments have received the proposal, and both recommend approval of the agreement.

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that the Manager of Planning and Zoning is authorized to enter into a professional services agreement with Community Planning and Development Advisors, LLC for a total sum not to exceed \$10,125.

BE IT FURTHER RESOLVED that funding for this purchase will be charged to the 2023 Community Development Block Grant Administrative funds using Account Number 220-7521-563-3002 Project #C23101.
