



Plaintiff, by its attorneys, Gray & Associates, L.L.P., pleads as follows:

- 1. The plaintiff is the current holder of a certain note and recorded mortgage on real estate located in this county, a true copy of the note is attached hereto as Exhibit A and is incorporated by reference. A true copy of the mortgage is attached hereto as Exhibit B and is incorporated by reference.
 - 2. The mortgaged real estate is owned of record by Gerald P. Griesemer.
- 3. The mortgage loan borrower, Gerald P. Griesemer, failed to pay Real Estate Taxes and/or maintain adequate hazard insurance, and under item 9(b)(iii) of the mortgage, the mortgagee has elected to accelerate the debt and there is now due and owing to the plaintiff the sum of \$195,204.49 plus additional interest and costs.
- 4. The plaintiff has declared the indebtedness immediately due and payable by reason of the default and has directed that foreclosure proceedings be instituted.
- 5. The mortgaged premises is a parcel of land which is 20 acres or less; with a one to four family residence thereon which is occupied as the homestead of the defendants; said premises cannot be

sold in parcels without injury to the interests of the parties.

- 6. The mortgagors expressly agreed to the reduced redemption period provisions contained in Chapter 846 of the Wisconsin Statutes; the plaintiff hereby elects to proceed under section 846.101 with a six month period of redemption, thereby waiving judgment for any deficiency against every party who is personally liable for the debt, and to consent that the owner, unless he or she abandons the property, may remain in possession and be entitled to all rents and profits therefrom to the date of confirmation of the sale by the court.
- 7. No proceedings have been had at law or otherwise for the recovery of the sums secured by said note and mortgage except for the present action, and all conditions precedent to the commencement of this action are satisfied.
- 8. That Jane Doe Griesemer has or may claim to have an interest in the subject encumbered property by virtue of being the present spouse of Gerald P. Griesemer.
- 9. That West Allis City has or may claim to have an interest in the mortgaged premises by virtue of a judgement against Gerald Griesemer in the amount of \$19,986.12, docketed June 19, 2009 as case number 08CV10904, but upon information and belief, said mortgage was paid in full and should be satisfied of record through accord and satisfaction.

- 2. That the amounts due to the plaintiff for principal, interest, taxes, insurance, costs of suit and attorney fees be determined.
- 3. That the defendants, and all persons claiming under them be barred from all rights in said premises, except that right to redeem.
- 4. That the premises be sold for payment of the amount due to the plaintiff, together with interest, reasonable attorney fees and costs, costs of sale and any advances made for the benefit and

preservation of the premises until confirmation of sale.

5. That the defendants and all persons claiming under them be enjoined from committing waste or doing any act that may impair the value of the mortgaged premises; and

That the plaintiff have such other and further judgment order or relief as may be just and equitable.

Borrower agrees that should this Security Instrument and the Note not be eligible for insurance under the National Housing Act within from the date hereof, if permitted by Applicable Law Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument. A written statement of any authorized agent of the Secretary dated subsequent to SIXTY DAYS from the date hereof, declining to insure this Security Instrument, and the Note shall be deemed conclusive proof of such ingligibility. Instrument and the Note, shall be deemed conclusive proof of such ineligibility. Notwithstanding the foregoing, this option may not be exercised by Lender when the unavailability of insurance is solely due to Lender's failure to remit a mortgage insurance premium to the Secretary.

10. No Deficiency Judgments. Borrower shall have no personal liability for payment of the debt secured by this Security Instrument. Lender may enforce the debt only through sale of the Property. Lender shall not be permitted to obtain a deficiency judgment against Borrower if the Security Instrument is foreclosed. 14. Forbearanceby Lender Not a Waiver. Any forbearance by Lender in exercising any right

agreements shall be joint and several.

16. Notices. Any notice to Borrower provided for in this Security Instrument shall be given by delivering it or by mailing it by first class mail unless Applicable Law requires use of another method. The notice shall be directed to the Property Address or any other address all Borrowers jointly designate. Any notice to Lender shall be given by first class mail to Lender's address stated herein or any address Lender designates by notice to Borrower. Any notice provided for in this Security Instrument shall be deemed to have been given to Borrower or Lender when given as provided in this Paragraph 16.

17. GoverningLaw; Severability. This Security Instrument shall be governed by Federal law and the law of the jurisdiction in which the Property is located. In the event that any provision or clause of this Security Instrument or the Note conflicts with Applicable Law, such conflict shall not affect other provisions of this Security Instrument or the Note which can be given effect without the conflicting provision. To this end the provisions of this Security Instrument and the Note are

declared to be severable.

18. Borrower's Copy. Borrower shall be given one conformed copy of the Note and this

Security Instrument.

NON-UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows: 19. Assignment of Rents. Borrower unconditionally assigns and transfers to Lender all the rents and revenues of the Property. 24. Attorneys' Fees. If this Security Instrument is subject to Chapter 428 of the Wisconsin Statutes, "Reasonable Attorneys' Fees" shall mean only those attorneys' fees allowed by that

Chapter.

25. ObligatoryLoan Advances. Lender's responsibility to make Loan Advances under the terms of the Loan Agreement, including Loan Advances of principal to Borrower as well as Loan Advances for interest, MIP, Servicing Fees and other charges, shall be obligatory.

26. Ridersto this Security Instrument. If one or more riders are executed by Borrower and recorded together with this Security Instrument, the coverages of each such rider shall be
