Last week Thursday, November 3, 2016, while driving my son home from school, I ran over debris in the road which was unavoidable. I was heading south thru the intersection of 76^{th} and Oklahoma on 76^{th} street in the left lane. There were cars in front of me and on the side. There was no way to avoid whatever was in the road and with the car in front of me, by the time I saw it, if I would've swerved, I would've hit the car next to me!

By the time I got to 76th and Layton my tire pressure sensor had gone off in my truck. I pulled over in the Barnes and Nobles parking lot and my son heard air rushing out from the back driver side tire. I immediately called the West Allis police department at 3:24pm to explain what had happened and what I should do to seek reimbursement if my tires were damaged. The officer gave me the number for the clerks office and I called at 3:29pm to get further information.

When we got home we found 12 large contractor staples in my tire as well as a large bolt. After putting on the spare on Friday, I took my truck to Girards Service in Franklin, WI to get a new tire and inspect the other tires to make sure there was no other damage. There was nothing in the other tires thank goodness!

I've enclosed the photos of the staples, tire, and my receipt from Girards. I hope I will be able to be reimbursed. I noticed yesterday on my way home with my son that there are cameras at that intersection. I wonder if you would be able to look back to catch the irresponsible person because I'm sure I was not the only one who got a flat tire that day!
