The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of January 2017

Incident reports:

Case #17-000027 // 01 January 2017 at 0407hrs. // One More – 7534 W. Beloit Rd. // NO VIOLATION

Caller was victim in incident – Eric Olson

On 01/01/17 at 0407 hours, officers were dispatched to 7534 W. Beloit Road to investigate a fight at the above location where a firearm was pointed and threats were made to the victim and his friends. The investigation revealed the firearm was never pointed at the victim, however the suspect did show the firearm and threaten the victim. All the victims in this case were extremely uncooperative with police on scene, and refused to give detailed statements regarding this incident. There are no known suspects regarding this incident.

Caller: Appears to be bartender or employee

Solie reports....CHAPTER 51 REFERRAL...On 01/15/17, I responded to Rock Star Saloon for an unresponsive male party. An unresponsive male was located inside the bar, and WAFD personnel had to use Narcan to revive him. The male became combative with WAFD after he was revived, and officers had to assist to keep him under control. The male was transported to Aurora West Allis Medical Center, and once there, the male stated he planned on killing himself by slitting his wrists once he was released. He wanted to receive treatment for his suicidal thoughts. Arrangements were made with Aurora staff to provide mental health treatment for the individual.

Officer Said reports: POINTING AND AIMING FIREARM... On 1-26-17 at approx. 0158 hrs, I responded to the GR's Pub (Newly named Retro PUB) 6827 W National Ave for a report of a male with a gun that threatened patrons who left the bar. Investigation revealed the victims were leaving the tavern and walking to their vehicle in the 1600 blk of S 69 St when they observed a male with a gun approach them on S 69 St. The male appeared to come from the north side of W National Ave and was described as a male/white or Hispanic in his 20's or 30's; between 5'08-5'10, approx. 180 lbs, wearing a hoody with a dark jacket over it that had buttons down the front, a baseball cap and holding a smaller sized semi-automatic pistol that is silver. The male pointed the gun at the female victim as she was outside her vehicle and continued to point it at her as she entered and started the vehicle and drove away with the male pointing the gun at her through the front passenger window. The female victim stated that she believed he said something to her, but she was not sure of what it was due to the stress of the situation. The male left in an unknown direction. The area was checked and no one found matching this description.
