The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of February 2017

#### **Incident reports:**

#### **OLDER JANUARY CASE**

 $\underline{\text{Case } \#17\text{-}001746}$  // 15 January 2017 at 0220hrs. // The Stallis Palace – 8812 W. Greenfield Ave. NO VIOLATIONS

Caller: Observed by on duty WI State Patrol officer

On 01-15-17 at 0220 hrs, officers responded to Stallis Palace, 8812 W. Greenfield Ave. regarding a disorderly conduct. Investigation revealed an intoxicated male was causing a disturbance and refusing to leave the area. The male individual was arrested for disorderly conduct, issued a municipal citation and released.

Caller: Proactive tavern check by West Allis Police

On 02/03/17 at approximately 2038 hours, officers conducted a tavern check at the 6500 Bar located at 6500 W Greenfield Ave. Investigation revealed they did not have a licensed bartender in the building. Contact was made with "manager" Montal L. Hinton M/B 02/2071 who advised the owner Tonja M. Basset F/B 06/02/70 was not on scene. Contact was attempted with the owner with negative results. The tavern was shut down until a licensed bartender arrived.

Contact was attempted later and there was no progress. Montal advised the tavern would be closed for the night. A tavern report will be completed as well as citations issued.

Caller: Complainant was alleged victim / employee

The West Allis Police Department is investigating a sexual assault complaint. A former employee complained of acts of sexual assault by another employee for the last several months. The investigation is still ongoing.

<u>Case #17-004557</u> // 05 February 2017 at 1929hrs. // The Drunk Uncle – 1902 S. 68 St. NO VIOLATIONS

Caller: Owner – Neal Steffek Three (3) calls. Female returned after being escorted out by police first two times.

On 02/05/17, officers responded to the Drunk Uncle, located at 1902 S 68 St, for a DC complaint. Officers made contact with a highly intoxicated female, who had two previous contacts at the same tavern within 40 minutes of this call. After repeated attempts to get her to leave, the female was ultimately arrested for DC. In the process of arresting her, she resisted and was decentralized. Caller: Deondre D. Harris – identified self as owner of tavern

On 02/08/17 at approximately 2227 hrs, officers responded to a report of a criminal damage. On scene, officers made contact with the owner of the bar, Deondre D. Harris, M/B, 11/02/75, who stated he heard the front window to his bar get broken. Upon exiting the business, he observed a M/W party walking north on S. 60 St. with a metal bat in his hand. Officers located the male party with the bat, at his nearby residence, who admitted to the offense. The male individual was taken into custody and issued a municipal citation for Criminal Damage with a court date of 03/13/17 at 0830 hrs.

#### Caller: Observed by reporting office on patrol

On 02/16/17 at 0156hrs, officers responded to a disorderly conduct incident at HD Hideout at 6201 W. Mitchell St. Investigation revealed Adam T. Covington, M/W 08/22/75 got into an argument with Cody J. Wilburth, M/W 12/08/94 and Shannon L. Redmond, F/W 01/07/73. Covington was highly intoxicated, and multiple witnesses advised he was the problem party. All parties were eventually sent on their way and agreed that no arrests should be made. Seiy, when he was located in the common stairwell to the apartments for the upstairs apartments. Seiy was intoxicated, knew the police were outside and would not give a statement as to why he did not answer the door. Seiy was issued a citation for refusing police permission to enter a licensed premise the court date is set for 03/13/17.

Her purse was found outside in the parking lot a short time later, with the wallet missing. The wallet contained credit cards and personal items, as well as a \$20.00 bill. The investigation revealed a possible known suspect and officers are in the process of obtaining video surveillance from the bar. First attempts to make contact with the suspect were unsuccessful.

Caller: Victim's wife – Carol J. Ruiz

On 2/18/17, Officers responded to 1042 S. 91st St. for an assault that took place at the above address. Carol J. Ruiz, (f/w, 1/23/81) called the WAPD to report her husband, Hector L. Ruiz, (m/w, 2/18/79) was assaulted while at Shepherd's by three unknown parties. Officers responded to Shepherd's and made contact with individuals in the bar who indicated Hector was the main instigator for this incident. The partie(s) who assaulted Hector were not on scene when Officers arrived and no one at the business knows their name.

National Ave where officers took him into custody. Stephen caused a disturbance on scene and in the booking area. Stephen was issued a citation for fraud on an inn keeper, and two citations for disorderly conduct.

#### Caller: Proactive tavern check by West Allis Police

On 02/09/2017 at approx. 2040hrs, officers responded to the 6500 Bar located at 6500 W Greenfield Ave to conduct a tavern check. Upon arrival, officers observed the tavern was open and patrons were inside. I made contact with a female identified as Tonja M Bassett F/B 06/02/1970 who advised she was the tavern owner. Tonja provided officers with her liquor license and advised she is a licensed bartender. While on scene, officers were approached by an unidentified subject who identified himself as partners with Tonja. Tonja appeared to know the male subject. The unidentified male was verbally argumentative with officers. The subject advised he felt officers were targeting the business. I attempted to explain that officers were conducting a check due to the recent incident involving a violation. The male party continued to be argumentative and told officers to leave the business. After reviewing this incident with Lt Pye, it was determined a tavern report would be generated documenting the uncooperative party inside of the business.

On 02/10/2017 officers responded back to 6500 Bar to conduct a check. Officers made contact with Tonja and the same male that was uncooperative on 02/09/2017. The male was identified as Montal L Hinton M/B 02/20/1971. Montal was cooperative during our contact with him on 02/10/2017.
