Upon deliberation and consideration of the complaint presented at the License and Health Committee meeting held on April 25, 2017, the Committee finds:

## **FINDINGS OF FACT:**

- That Hideout West Allis Inc., by agent Daniel R. Seiy, was properly served a copy of the summons and complaint, pursuant to Wis. Stat. Sec. 125.12(2)(ar) and West Allis Revised Municipal Code (hereinafter referred to as "West Allis RMC") Section 9.02(2)(d)1.
- 2. That Hideout West Allis Inc., by agent Daniel R. Seiy, appeared at the License and Health Hearing on April 25, 2017, and affirmed that he was admitting to the facts contained in the complaint and was not contesting the complaint.
- 3. That based upon the facts within the complaint that the License and Health Committee has accepted as true on April 25, 2017, and which substantially relate to the licensed activity, Hideout West Allis Inc., by agent Daniel R. Seiy, has maintained a disorderly or riotous, indecent, or improper house in violation of Wis. Stat. Sec. 125.12(2)(ag)2, West

Allis RMC 9.02(12)(c) and 9.02(20)(a)6; has sold alcohol to intoxicated persons in violation of Wis. Stat. Sec. 125.07(2)(a)(2) and West Allis RMC 9.02(20)(a)3; has failed to have a licensed operator on premises who is able to supervise nonlicensed bartenders in violation of Wis. Stat. Sec. 125.32(2); and had failed to cooperate with a police investigation in violation of West Allis RMC 9.02(12)(b).

## **CONCLUSIONS OF LAW:**

- That on at least two occasions, Hideout West Allis Inc., has violated the laws of
  Wisconsin and the City of West Allis with regard to keeping a disorderly or riotous,
  indecent, or improper house.
- 2. That on at least one occasion has failed to cooperate with police investigations.
- That on at least one occasion has failed to have a licensed operator on premises who
  is able to supervise nonlicensed bartenders.
- 4. That on at least two occasions had provided alcohol to intoxicated persons.

## **RECOMMENDATION:**

Therefore, the License and Health Committee recommends to the Common Council
of the City of West Allis that the Class "B" intoxicating Liquor and Class "B"
Fermented Malt Beverage License under license number 1840 and the Instrumental
Music License under license number be suspended for 15 days.
