Upon deliberation and consideration of the complaint presented at the License and Health Committee meeting held on April 25, 2017, the Committee finds:

## **FINDINGS OF FACT:**

- That JM 6500 Investments Limited Liability Company, by agent Tonja Bassett, was
  properly served a copy of the summons and complaint, pursuant to Wis. Stat. Sec.
  125.12(2)(ar) and West Allis Revised Municipal Code (hereinafter referred to as
  "West Allis RMC") Section 9.02(20)(d)1.
- 2. That JM 6500 Investments Limited Liability Company, by agent Tonja Bassett, failed to appear to the License and Health meeting that took place on April 25, 2017, therefore allowing the committee to take the allegations in the complaint as true under West Allis RMC 9.02(20)(d)4.
- 3. That based on the facts within the complaint that the License and Health Committee accepted as true on April 25, 2017, and which substantially relates to the licensed activity, JM 6500 Investments Limited Liability Company, by agent Tonja Bassett,

has maintained a disorderly or riotous, indecent, or improper house in violation Wis. Stat. Sec. 125.12(2)(ag)2, West Allis RMC 9.02(12)(c) and 9.02(20)(a)6; has failed to have a licensed operator or bartender on premises in violation of West Allis RMC Section 9.02(16) and Wis. Stat. Sec. 125.32(2); that employees of the 6500 Bar have failed to cooperate with police investigation in violation of West Allis RMC 9.02(12)(b); and that the 6500 Bar has had overflowing garbage at the licensed premises in violation of West Allis RMC 7.04(16)(5).

## **CONCLUSIONS OF LAW:**

- That on at least two occasions, JM 6500 Investments Limited Liability Company has
  violated the laws of Wisconsin and the City of West Allis with regard to keeping a
  disorderly or riotous, indecent, or improper house.
- That on at least two occasions, JM 6500 Investments Limited Liability Company has
  violated the laws of Wisconsin and City of West Allis by failing to have a licensed
  operator or bartender on premises.
- That on at least two occasions, JM 6500 Investments Limited Liability Company has
  violated the West Allis RMC by failing to cooperate with police investigations on the
  premises.
- 4. That the West Allis Health Department has received complaints and verified that JM 6500 Investments Limited Liability Company has had overflowing garbage on premises in violation of the West Allis RMC.
- 5. That the foregoing Conclusions of Law substantially relate to the licensed activity and constitute a sufficient basis to revoke the "Class B" intoxicating Liquor and Class "B" Fermented Malt Beverage License under license number 2335, the Dance Hall

License under license number 2336, the Tavern Entertainment License under license number 2337, and the Food Permit with identification number CSAC-AAYHJF.

## **RECOMMENDATION:**

1. Therefore, the License and Health Committee recommends to the Common Council of the City of West Allis that the Class B" intoxicating Liquor and Class "B" Fermented Malt Beverage License under license number 2335, the Dance Hall License under license number 2336, the Tavern Entertainment License under license number 2337, and the Food Permit with identification number CSAC-AAYHJF, all associated with 6500 Investments Limited Liability Company, be revoked.
