The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of April 2017

Incident reports:

Case #17-011753 // 01 April 2017 at 0253hrs. // Harry O's Second Base – 6743 W. Lincoln Ave. – NO VIOLATION

Caller: Employee – Teresa Rowe-Weasler

Criminal Damage to Property: On 04/01/2017 at approximately 0253hrs., I was dispatched to Harry O's, 6743 W. Lincoln Ave., for a Criminal Damage to Property Complaint. Investigation determined that an unknown subject walked past the bar on the sidewalk and punched the window, causing it to break. The area was checked for the suspect and they were not located. Damage was estimated at \$200.00.

Investigation revealed there was an argument between Cali R Schmidt, F/W and Nicholas J. Damato, M/W, who have two children in common. Disorderly Conduct / Go Armed While Intoxicated: On 4/16/17 at about 0055hrs, officers responded to possible shots fired outside 6500 Bar (6500 W Greenfield Ave). On scene a large crowd of adults were observed physically fighting the street. Officers were unable to determine who fired the shots but confirmed an unknown male fired at least one round into the air and the fled from the scene. Several were taken into custody for varying offenses. Monique P. Baldwin (F/B) was arrested for Going Armed While Intoxicated and Disorderly Conduct. Roger L. Hughey (M/B) was also arrested for Going Armed While Intoxicated. Crystal D. Baldwin (F/B) was arrested for municipal disorderly conduct. Assault: On 04/22/17, at approximately 0109hrs, officers responded to 1438 S. 92nd St for a report of an assault. Upon arrival contact was made with Suzzette M. Grisham (F/W,). Investigation revealed that Grisham was attacked by two women outside Jock Stop (7930 W. National Ave) by two unknown women; which resulted from a verbal altercation inside the bar. Grisham received injuries to her forehead and her nose during the incident. Follow up was conducted at the Jock Stop and we were unable to determine the identities of the two offenders.

Underage Alcohol: On 04/23/2017 at 0119hrs., officers responded to Burnham Bowl for an intoxicated male that would not leave the business after being escorted out twice. Upon entering the business that staff pointed out the male, later identified as Guadalupe NMN Nunez Jr. (M/W) who was the subject of the complaint. Nunez was arrested for underage alcohol consumption. A citation was also issued to Beierle for Procure/Sell/Dispense Alcohol to Underage – 1st Offense.

Tammy stated Mark told her about the alarm and she looked at her surveillance tapes and discovered it wasn't a false alarm as she observed two individuals in the bar at the time of the alarm. Tammy believes they are friends of the bartender who was on duty that night by the name Tracey Hinzpeter. Tammy also stated her surveillance shows these two were in the bar shortly before it closed and shows Tracey letting them out of the back door. She said their names are Daniel Stefonich and his brother Joseph Stefonich. Tammy stated the offenders were were captured on her surveillance rummaging through the cabinets looking for what she suspects to be the money from the days business. She said they didn't find the money and was in one of the cabinets that wasn't checked by the offenders. Tammy gave me a flash drive of the surveillance that was placed on property.

Nicole stated she could not be certain a drug deal took place however she believes that is what is happening outside of the business. Nicole requested officers checked the area to locate where the smell was coming from. Officers did not smell any odor of marijuana while inside of the business and did not observe any problems inside of the bar. Nicole was advised to continue to contact WAPD if there are further issues. Nicole advised she attempted to contact the owner on multiple occasions regarding tobacco smoke however he never responded. A tavern report was generated regarding this incident. A tavern check was also completed under call #17-013848 after investigating this incident.

Related Tavern Check // Call #17-013848: On 04/15/2017 at approx. 2119hrs, officers responded to Boosters West to investigate an incident under call #17-013848. After conducting the investigation officers conducted a tavern check at the bar to verify there were no issues. Bartender Jennifer S Hallisch F/W provided her bartender license card 17-453 which was valid through 2017. I also observed that the business had proper licensing displayed in a visible place behind the bar. Officers walked the business and observed no problems.

Suspicious Activity / Warrant Arrest: Officers responded to a fight call involving a black male in a suit "squaring up" with another male in the street. I located Billy Dee Evans who was the only black male in a suit in Flappers, where the caller said he went. Evans was ultimately given a warning for the incident. Evans was found to have two valid, confirmed warrants through Mequon PD which he could not post on. Mequon PD asked us to transport Evans to CJF. Evans was subsequently transported to CJF.

I observed numerous people in Flappers after closing time (0200 AM). At 0204hrs, which I confirmed through dispatch and MDC and cell phone, I walked into Flappers and observed about six people just leaving the bar area of the tavern and walking out the door. There was one pitcher and one bottle of beer still on the bar from where the group was walking away. The on duty bartender, Melissa K Rumsey (F/W), said she had trouble getting them to leave, someone's ride had not come yet and they had been waiting in the bar, and the clock in the tavern was off. I advised Rumsey it was her responsibility to ensure all people were out and all drinks were not available for consumption by tavern closing time. Rumsey had a valid West Allis bartender's license (#18179 issued 08/03/16) and the tavern's liquor license was displayed (#16-797). Tavern violation report completed.
