Dear ADA office:

I am writing this for 2 reasons. The first is to thank you for pursuing a prosecution of Joshua Lancello. I agree with the plea for a reduced sentence which effectively just revokes his probation for his drug offenses. However, I want to take a moment to point your attention to the party that you have not pursued as of yet.

A thief will only steal if he has a place to fence the stolen property. My opinion is that Kory P. at Pawn America needs to be reminded of the seriousness of dealing in stolen merchandise. I'm sure that if he honestly and without knowledge receives property that is stolen he can't be held responsible. However, that is not the case here. A summary of the facts are presented below:

- 1. Upon discovering the theft limmediately brought in the West Allis Police and gave them a list of the stolen property.
- 2. Upon believing the property was fenced at Pawn America I met with Kory P. who told me that he did not have my merchandise.
- 3. Same day the West Allis Police visited with Kory P. who did acknowledge receipt of the stolen property and Pawn America released half of the property back to the police who returned the items to me
- 4. On February 9th I emailed Pawn America reminding them of the list of stolen items and demanded a return of my property
- 5. In April the ADA's office called me and said Kory P at Pawn America agreed to return the remainder of the stolen property.
- 6. I immediately returned to the store to be told by Kory that he would only cooperate with the police.
- 7. The police arrived (same officer who took the report and met with Kory in the past), only to be told by Kory that he both sold some of my property and transferred the remainder to another store location.

^ The way I see it Kory P./Pawn America is a party to a felony burglary

^ In addition: I believe he violated his City of West Allis of deceptive practices when they transferred my property to another location to shield the property from the police.
