## 12/25/17 6:30 a.m. Christmas Day

Woke up to no running water, started calling around to see if anyone was able to come out. Only one Company out of 10 called us back only to say they would only come out if it was a Heating Emergency, this was Mobile Home Stuff Inc. in Fond Du Lac, WI. After explaining to "Chris" our problem he said it sounded like a freeze up and not much we could do unless we had lots of portable heaters that we could put underneath our skirting to warm it up.

Chris said he could put us on the list for tomorrow mornings Schedule.

#### 12/26/17 10:00 a.m.

Chris & his helper arrived and began studying why our pipes were frozen, They found that our heat taped was cut right next to our New water meter that was installed in May by a City worker "Cole" (who no longer is employed with the City) Cole never told us he did this and that we would have to replace our heat tape for the winter. My Husband Bob remembers him well, Cole was very very tall and my Husband gave him pads to kneel on, Cole was not prepared or seemed interested, (not into his job) my Husband remembers.

See photo's we took of damage found, before any repair work began, Also see attached actual heat tape that was cut, We saved to show you.

Chris said the bottom of the water meter was cracked from the cold & would have to be replaced too. So we called the West Allis Water Dept. at (414) 302-8830 and spoke to Jeanine, the first thing she said was "Didn't we receive the letter they send out every year to check heat tape to prevent freeze ups?", I told her of course & our Heat tape light was on! We didn't know that if someone cut through it that the light would remain on. Why didn't her meter guy tell us he cut through it? Now she put us on speaker phone with her other Tech "Todd", so my repairman Chris could talk directly to him regarding what was needed.

Your Tech "Todd" couldn't come out for another Hour and told my repairmen that he would only connect the meter and they would have to connect new pipes and new heat tape. So that meant my repair men would have to wait for when ever he showed up because they weren't driving back & forth to Fond Du Lac.

### 12/26/17 12:20 p.m.

I called the city again "Jeanine" I told her their truck went to the wrong trailer & left ?? She then called him & Todd said he saw one of their trucks at another trailer & stopped thinking it was ours, He was told everything was taken care of, so he left. Jeanine sent him back to us, he said what are the chances that two trailers in the same park had the same problem.

Now after talking to the neighbors, We find that your City worker cut through others heat tape too, Three that I have found so far, Everyone was having new meters installed, lucky for you it has been so bitter cold I haven't been able to stop and ask everyone YET!

Trailers #52 and #79 also had their Heat tape cut when their meters were installed by the city.

A claim was filed for Trailer # 52 which you denied. WHY?? I believe they will be appealing due to this new evidence.

Also, We had ALL new Plumbing and Heat Tapes installed in 2013 – Check your permits, We had your inspector out several times to make sure everything was installed correctly by our Plumber. I still have all e-mails saved.

We expect to be reimbursed not only for the repair bill for that Day from Mobile Home Stuff, Inc. of \$586.00 but also have any bill from the City of West Allis for the new meter of \$70.00 Be removed & cancelled, not to mention my wage I lost to stay home for the repair men \$ 7.5 hours @
