Thank you for taking the time to talk to me about the new Kwik Trip convenience store that we are planning to build in the City of West Allis. We discussed Kwik Trip's interest in applying for a Class-A Alcohol license for this store in the future.

Over the past few years we have been expanding our food selections to include more meal preparation ingredients including fresh produce and meats. As a result, our customers can shop for an entire meal with one "Kwik" stop at their local Kwik Trip store. We hope to add to their shopping convenience at the West Allis location by having alcohol products available to purchase as well.

Kwik Trip currently holds 375 alcohol licenses in Wisconsin. Kwik Trip has been recognized as an industry leader for enforcing I.D. checks for all age-restricted products. Our co-workers take great pride in the excellent compliance record they achieve in identifying underage customers. Enclosed is a copy of our Alcohol and Tobacco Sales policy. Please note that coworkers complete our own in-house alcohol and tobacco training program upon hire as well as complete the state-mandated Learn2Serve training in order to obtain Operator Permits. In addition, Kwik Trip performs our own compliance checks to ensure that coworkers are diligent in age-restricted product sales.

We are certain that West Allis can appreciate the value of adding a growing, thriving business like Kwik Trip to the business community. In addition to adding 25 to 30 jobs with above-average wages and benefits, it will also add to the tax base for decades to come. The 5,500 square foot state-of-the-art convenience store will be attractive to residents as well as visitors.

I would ask that you include our request to apply for an alcohol license in the future on the agenda of your License and Health Committee meeting for consideration. 

Kwik Trip, Inc. was incorporated in Wisconsin on October 7, 1964 and has been operating Kwik Trip convenience stores since 1965. Kwik Trip is a vertically-integrated organization with its own bakery, dairy, ice plant, beverage plant, commissary, trucking fleet and distribution center. The company employs over 21,000 coworkers who work throughout the States of Wisconsin, Minnesota and lowa. The corporation is a privately-held corporation, owned by the Zietlow family. Donald Zietlow is the company President and CEO.

An estimated 25 to 30 coworkers will be employed at the future West Allis convenience store (representative plan enclosed). Job duties will consist of sales cashiers, food preparation, stock crew, cleaning and a leadership team. Kwik Trip offers above-average wages, benefits and 40% profit sharing (benefit summaries enclosed).

The products sold in the store will be various items including prepared food, grocery foods, fresh meat, dairy products, hot and cold beverages, bakery, fresh fruits and vegetables, snacks, sundry items, tobacco products and off-sale alcohol. There will be a small snack-counter area available for short-term use by customers to consume their purchases. Coworkers complete the ServeSafe food safety training. The manager of the store will hold a Food Safety Manager Certificate.

Coworkers complete our in-house alcohol and tobacco training program (copy enclosed). In addition, they complete the State-approved Learn2Serve Responsible Beverage Operator training program. Coworkers who work at the sales counter will also obtain a West Allis Operator Permit. Kwik Trip has a comprehensive Tobacco and Alcohol Sales Policy that spells out the rewards and discipline for passed or failed compliance checks (copy enclosed). Kwik Trip performs our own in-house compliance checks to ensure that coworkers are diligent in asking for identification for age-restricted products. In addition, our point-of-sale system ensures that products are sold only during allowed hours and that customer's identification is scanned before an age-restricted sales transaction can be completed.



SITE PLAN



ARTICLE II.

Purposes

- 1. To own, conduct, operate, maintain, and carry on a general grocery and convenience store business, gasoline and oil business, at wholesale or retail, in the State of Wisconsin pursuant to Chapter 180 of the Wisconsin Statutes, and at such other place or places as may be determined by the Board of Directors of this Corporation;
 - 2. To acquire, hold, lease, let, dispose of, and deal in real estate;
- 3. To purchase or otherwise acquire, hold, own, use, pledge, mortgage, sell, convey, or otherwise dispose of real and personal property of every kind and description, without restriction or limitation as to amount in any of the states, territories, districts, or possessions of the United States, or in any foreign countries, except where otherwise provided to the contrary by law;

- 4. To acquire, hold, sell, exchange, transfer, or otherwise deal in shares of its own capital stock, bonds, or other obligations from time to time, to such an extent, in such manner, and upon such terms as its Board of Directors shall determine;
- 5. To purchase, hold, sell, exchange, transfer, or otherwise deal in shares of its own capital stock, bonds, or other obligations from time to time, to such an extent, in such manner, and upon such terms as its Board of Directors shall determine;
- 6. To hold, purchase, otherwise acquire, or be interested in, and to sell, assign, pledge, or otherwise dispose of shares of the capital stock, bonds, or other securities issued or created by any other corporation, whether foreign or domestic, and whether now or hereafter organized, and while the holder of any such shares of stock, to exercise all the rights and privileges of ownership, including the right to vote thereon to the same extent as a natural person might or could do;
- 7. To purchase, lease, or otherwise acquire, and to hold, exercise, and enjoy all or any of the property, franchises, goodwill, rights, powers, and privileges held or enjoyed by any individual, association, partnership, corporation, or other legal entity, and to undertake the liabilities of such individual, association, partnership, corporation, or other legal entity;
- 8. To apply for, obtain, register, purchase, lease, or otherwise acquire, and to hold, use, operate, and introduce, and to sell, or otherwise dispose of any trademarks, tradenames, copyrights, patents, inventions, improvements, and processes used in connection with or held under any patents of the United States, or elsewhere, which may be used in connection with or appertaining to any kind of business hereinbefore set forth and described, and to use, exercise, develop, grant licenses in respect of, or otherwise to turn to account any such trademarks, tradenames, copyrights, patents, licenses, processes, and the like, or any such property or rights;

- 9. To enter into any arrangement with others for the sharing of profits or union of interest with respect to any transaction, operation, or venture which the corporation has power to conduct by itself, even if such arrangement involves sharing or delegation of control of such transaction, operation, or venture with or to others;
- 10. To borrow money for its corporate purposes, and to draw, make, accept, endorse, execute, and issue bonds, notes, debentures, bills of exchange, warehouse receipts, warrants, and other negotiable instruments and obligations, and in order to secure the same, or any of its contracts or obligations, to convey, transfer, assign, mortgage, pledge, and deliver all of any part of the property of this corporation upon such terms and conditions as the Board of Directors shall determine.
- 11. To loan, lend, and guarantee all forms of monies; to act as a guarantor and/or surety on the obligations of other persons or corporations to such an extent, in such a manner, and upon such terms as its Board of Directors shall determine, even if this corporation shall have no direct or indirect interest in the affairs, ownership, or operations of such other persons or corporations;
- 12. In general, to carry on all business and to have and exercise all of the powers conferred by the laws of the State of Wisconsin on corporations, and to do any and all acts and things herein set forth to the same extent as natural persons could do, and in any part of the world, as principal, factor, guarantor, agent, contractor, partner, joint venturer, trustee, or otherwise, either alone or in syndicates, or otherwise in conjunction with any person, entity, syndicate, partnership, association, or corporation, domestic or foreign;

ARTICLE III.

Capital

- Section 1. Authorized Shares The authorized capital stock of this corporation shall consist of the following Classes of Common Stock:
- 1.1 <u>Class A Voting Common Stock</u> The authorized Class A voting common capital stock of this corporation shall consist of One Hundred Million (100,000,000) shares of voting common stock without par value, each outstanding share of which shall be entitled to one vote per share on each matter which shall be presented to a vote of the shareholders of the corporation.
- 1.2. Class B Non-Voting Common Stock

 The authorized Class B non-voting common capital stock of this corporation shall consist of Three Hundred Million (300,000,000) shares of non-voting common stock without par value, no outstanding share of which shall be entitled to vote on any matter which shall be presented to a vote of the shareholders of the corporation.

In each and every respect, other than voting privileges, Class A and Class B shares of capital stock shall be equal.

Section 2. Preemptive Rights Each share of the corporation shall entitle the holder thereof to a preemptive right, for a period of ninety (90) days, to subscribe for, purchase or otherwise acquire (i) any shares of stock of the corporation, of (ii) any rights or options which the corporation purposes to grant for the purchase of shares of stock of the corporation or for the purchase of any shares, bonds, securities, or obligations of the corporation which are convertible into or exchangeable for, or which carry any rights to subscribe for, purchase, or otherwise acquire unissued shares of stock of the corporation, whether now or hereafter authorized or

created, and whether the proposed issue, reissue, or grant is for case, property, or any other lawful consideration; and after the expiration of said thirty (30) days, any and all of such shares, rights, options, bonds securities, or obligations of the corporation may be issued, reissued, or granted by the Board of Directors, as the case may be, to such individuals and entities, and for such lawful consideration, and on such terms as the Board of Directors in its discretion may determine.

Section 3. Stock Rights and Options Subject to Shareholders' preemptive rights, the corporation shall have the power to create and issue rights, warrants, or options entitling the holders thereof to purchase from the corporation any shares of its capital stock of any class or classes, upon such terms and conditions and at such times and prices as the Board of Directors may provide, which terms and conditions shall be incorporated in an instrument or instruments evidencing such rights. In the absence of fraud, the judgment of the Directors as to adequacy of consideration for the issuance of such rights or options and the sufficiency thereof shall be conclusive.

Section 4. <u>Uncertificated Stock</u> The authorized Class A voting and Class B non voting common capital stock shall be issued in uncertificated form. Certificated shares issued prior to February 13, 2012 in certificated form are surrendered to the Corporation and are considered obsolete. Uncertificated shares are recorded on Kwik Trip, Inc.'s books and owners have the same rights and benefits as if they held certificated shares. Written statements will be issued within a reasonable time after the transfer of uncertificated shares to the shareholders transferring and receiving shares and also upon request from an individual shareholder.

ARTICLE IV.

Registered Agent

The name of the Registered Agent at the time of adoption if this Sixth Restatement of the Articles of Incorporation is Thomas E. Reinhart who shall continue to act as such until some other person is designated for that purpose by the Board of Directors of this corporation.

ARTICLE V.

Registered Office

The location and post office address of this corporation within the State of Wisconsin shall be at such place as may be designated for that purpose from time to time by the Board of Directors, and until some other place is designated for that purpose by the Board of Directors, the location and post office address of the registered office of this corporation at the time of adoption of this Sixth Restatement of the Articles of Incorporation is:

ARTICLE VI.

Board of Directors

Section 1. The number of directors and manner of electing directors shall be as set forth in the corporation's By-Laws and such By-Laws may be amended from time to time. The By-Laws may provide that the terms of directors be staggered.

Section 2. The Board of Directors may provide for the appointment of such additional officers as they may deem to be in the best interest of the corporation. Whenever the

Board of Directors may so order, the statutory Offices of Secretary and Treasurer; President and Treasurer; or Vice President and Secretary may be held by the same person.

The said officers shall perform such additional or different duties as may from time to time be imposed or required of them by the Board of Directors or as may be prescribed from time to time by the By-Laws of the Corporation.

ARTICLE VII.

Shareholder Authorization

Except as hereinafter provided, the requisite number of affirmative votes, for adoption or approval of any action to be affirmed, adopted, or approved by the shareholders of this corporation shall be a simple majority vote of the outstanding shares.

An affirmative vote of eighty percent (80%) of all of the outstanding voting shares of the common capital stock of the corporation shall be the requisite vote to:

- 1. Amend the Sixth Restatement of the Articles of Incorporation; and/or
- 2. Sell, lease, or otherwise dispose of all, or substantially all of the property of this corporation, whether or not in the usual and ordinary course of business; and/or
- 3. Approve and carry out a plan of merger, consolidation or share exchange whether or not this corporation is to be the merging, surviving or consolidated corporation except for plans of merger or share exchange wherein the merging corporation is a subsidiary of this corporation within the meaning of Wisconsin Statute Section 180.1104, as from time to time amended, which mergers or share exchanges shall be governed by the Wisconsin business corporation law; and/or
- 4. Approve and carry out the liquidation or dissolution of this corporation pursuant to the Wisconsin business corporation law.

5. Approve any offering of shares or securities convertible into shares of the common capital stock of the corporation.

This Sixth Restatement of the Articles of Incorporation correctly sets forth the provisions of the Articles of Incorporation as heretofore and hereby amended; have been duly adopted as required by law; and supersede the original Articles of Incorporation and all amendments and Restatements thereof.

Alcohol and Tobacco/Nicotine Sales Policy

You must ask for the guest's ID and scan/swipe the ID or enter the guest's birthdate on the register when guest is purchasing:

- Alcohol products and they look younger than 30 years of age*
- Tobacco products and they look younger than 30 years of age*
- Electronic cigarettes and liquid nicotine products and they look younger than 30 years of age*
- * Exception: 1.) Unless you have previously verified their age and ID, AND/OR 2.) Know the person by name and they are of legal age to purchase alcohol and tobacco products.

<u>Note</u>: Under no circumstances can a co-worker accept the "OK" or approval by another co-worker as a substitution for proper identification. The Co-worker scanning the product must be the person checking the ID or approving the "Exception".

Only these forms of guest ID are valid:

- Valid, picture US driver's license
 - MN: An Expired ID is only a valid proof of age for the purchase of age restricted products when shown in conjunction with the new temporary ID.
 - <u>WI</u>: The paper temporary Driver's license or ID card is a valid form of identification if it contains the photo and bar code used to check the age of the guest.
 - o <u>IA</u>: The paper temporary Driver's license or ID card is a valid form of identification if it contains the photo and bar code used to check the age of the guest. A License Renewal Kiosk "Proof of Transaction" can be accepted as a valid ID for up to 21 days after the issue date, as long as it is still legible, when shown in conjunction with the expired ID. This is the only exception to the requirement to scan/swipe all IDs as it does not include a bar code.
- Valid, US State-issued picture identification card (must include picture and date of birth- example: an IA Donor Card)
- Picture US military identification
- Valid passport
- Valid Wisconsin or Minnesota Tribal Identification Card (must include legal name, date of birth, signature and photo of the enrolled tribal member)
- Valid Permanent Resident Card ("Green Card")

However, if the ID is in question at all, DO NOT MAKE THE SALE!

Do Not sell alcohol to anyone who is:

- Obviously intoxicated
- Attempting to purchase before or after the selling hours established by your municipality

Do Not sell alcohol, tobacco, electronic cigarette or liquid nicotine products to anyone who is:

- Going to give or resell the product(s) to an underage person
- Under the legal age
- Cannot produce a valid ID

Policy Enforcement

- Kwik Trip, Inc., and/or local agencies, will periodically send a mystery shopper to purchase alcohol, tobacco, electronic cigarette, or liquid nicotine products.
- If you ask for identification from the Kwik Trip mystery shopper, swipe the ID or enter the birthdate, and are wearing your nametag, you will receive a \$10.00 gift certificate.
- If you fail to ask for, and swipe/scan the ID or enter the Birthdate on the register for the identification of the mystery shopper, or any other mystery shopper from a government agency, you will be disciplined accordingly.
- All violations will be dated the day of the incident, when known. All other incidents will be dated the day that Kwik Trip, Inc. is made aware of the violation.
- If the original 24-month monitoring period expires and the individual has other violation(s), the date of the next violation denotes the beginning of a new 24-month monitoring period. Therefore, individuals with violations will be in a monitoring period until 24 months pass without a violation.

Store Violations and Discipline:

- The Store Leader/acting Store Leader will receive a violation if a co-worker fails any type of ID check prior to having completed the Alcohol and Tobacco/Nicotine Sales training.
- If your store has 2 violations of this policy within 6 months, the Store Leader will hold a mandatory re-training session with all store co-workers.
- If your store has 3 violations of this policy within 6 months, the Store Leader will work an alternate shift with the last offender. During their shift, the Store Leader will train and coach the co-worker on how and when to verify ID for alcohol and tobacco products. In addition, the District Leader will hold a mandatory re-training session with all store co-workers.
