Chapter 51: Officer Santa Cruz Medina: On 10/29/18 at 2357hrs, officers responded to S 58 St/W Burnham St for a female subject lying in the middle of a parking lot. Officers located the intoxicated female, Nancy J. Clark, F/W and observed she had significant facial injuries and a laceration to her left hand. Clark was transported and admitted to Froedtert Hospital for the injuries. It appears that Clark who has no recollection of the events, may have fallen after leaving the Rock Star Saloon and reaching the parking lot where she was found. Clark sent suicidal text messages to her boyfriend and was placed under a Chapter 51 ED. All the paperwork was completed and turned over to MCMH. An apprehension request form was completed and turned over to the C.O. Investigation to continue.
