 - b) Interfaith West Central Resource Center. Tammy Herro reported that Interfaith has 619 clients. She said there have been some changes since Unison became the organization's new name. Neighborhood Outreach Program West Central Office is the program's name. The parent agency is Unison. Tammy also reported that since Carmen resigned, the new

position is now more volunteer based. She also mentioned that Volunteers United posts volunteer opportunities, but it is difficult getting responses as there are 92 pages of volunteer opportunities.
