I, Brian E. Sandberg, a Wisconsin Professional Land Surveyor, certify that I have surveyed, divided and mapped a division of Parcel 3 of Certified Survey Map Number 6388, recorded at the Milwaukee County Register of Deeds office as Document Number 7398804, being part of the Northeast 1\4 and the Southeast 1\4 of the Southwest 1\4 of Section 34, Town 7 North, Range 21 East, in the City of West Allis, Milwaukee County, Wisconsin, bounded and described as follows:

Commencing at the South 1\4 corner of said Section 34; thence North 1°01'10" West coincident with the North South 1\4 line of said Section 959.83 feet; thence South 88°53'27" West 29.31 feet; thence North 61°47'49" West 59.86 feet to the Southeasterly corner of said Parcel 3 and the point of beginning; thence continuing North 61°47'49" West 89.46 feet to a point; thence South 88°55'24" West 295.73 feet to a point; thence South 1°04'44" East 267.00 feet to a point; thence South 88°58'47" West 74.68 feet to a point; thence South 1°01'17" East 172.77 feet to a point; thence South 88°52'24" West 107.35 feet to a point on the East Right of Way line for South 70th Street; thence North 1°04'08" West coincident with the East line of South 70th Street 995.88 feet to a point of curve to the right having a radius of 19.89 feet and a chord bearing North 44°05'06.5" East 28.21 feet; thence along the arc of said curve 31.35 feet to a point on the South Right of Way line of West Washington Street; thence North 89°14'21" East coincident with said South line 159.70 feet to a point on the South Right of Way line of West Washington Street; thence North 84°22'47" East coincident with said South line 200.72 feet to a point on the South Right of Way line of West Washington Street; thence North 89°14'21" East coincident with said South line 176.64 feet to the Northeast corner of said Parcel 3; thence South 1°01'17" East coincident with the East line of said Parcel 3, 633.78 feet to the point of beginning. Containing 393,048 square feet or 9.023 acres.
