Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against Esveiri Escobar d/b/a Escobar's Kitchen as follows:

- 1. That the complainant is a resident of the City of West Allis, is the duly elected

 Alderperson for the First Aldermanic District in the City of West Allis, is the chair of
 the License and Health Committee, and makes this complaint at the direction of the
 License and Health Committee of the West Allis Common Council.
- 2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis, which records complainant believes to be reliable and accurate.
- 3. That Escobar Kitchen LLC is the holder of Class "B" Fermented Malt Beverage
 License Number 18-2624 which was conditionally granted by the West Allis
 Common Council for the license ending June 30, 2019, for the premises located at
 9130 W. Greenfield Avenue, West Allis, Wisconsin and does business under the
 trade name "Escobar's Kitchen."
- 4. That Esveiri Escobar is the licensing agent for Escobar Kitchen LLC.
- 5. That on November 5, 2018 the Common Council conditionally approved the Class

- "B" Fermented Malt Beverage License to Escobar Kitchen LLC subject to the necessary requirements of obtaining said licenses.
- 6. That pursuant to West Allis Revised Municipal Code Section 9.02(6), applicants are required to obtain inspections from the Building Inspection and Neighborhood Services Department before an alcohol-related license may be formally issued.
- 7. That as of April 17, 2019, Esveiri Escobar has failed to obtain that inspection and in fact and pursuant to observations of the West Allis Building Inspection Department, is no longer operating at that location.
- 8. That on March 20, 2019, Escobar Kitchen LLC through licensing agent Esveiri Escobar was ordered to appear at the License and Health Committee meeting that took place on March 26th at 6:00 P.M. Esveiri Escobar did not appeared at the meeting or and did not make contact with the Committee prior to the meeting.
- 9. That the registered contact information is no longer in service or accepting any phone calls.
- 10. That Escobar Kitchen LLC has not conducted licensed activity at the licensed premises for more than 30 consecutive days.
- 11. That the conduct of Escobar Kitchen LLC substantially relates to the licensed activities and is contrary to West Allis Revised Municipal Code Sections 9.02(9)(c), 9.02(12)(b), and 9.02(12)(d), is contrary to the provisions of Chapter 125, Wis. Stats., specifically Wis. Stat. Sec. 125.12(2)(ag)1 for failure to comply with statutory and municipal regulations; and that the conduct of Esveiri Escobar d/b/a is grounds for non-renewal, suspension, or revocation of its Class "B" Fermented Malt Beverage License Number 18-2624.

WHEREFORE, Michael J. Czaplewski, requests that Escobar Kitchen LLC by licensing

agent Esveiri Escobar, be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Class "B" Fermented Malt Beverage License Number 18-2624 of Escobar Kitchen LLC should be revoked, suspended, or not renewed.
