Upon deliberation and consideration of the complaint presented at the License and Health Committee meeting held on April 23, 2019, the Committee finds:

## **FINDINGS OF FACT:**

- That Vani's Kitchen, Inc., by Agent Vigneshar Bhadharla, was properly served a copy of
  the summons and complaint, pursuant to Wis. Stat. Sec. 125.12(2)(ar) and West Allis
  Revised Municipal Code (hereinafter referred to as "West Allis RMC") Section
  9.02(2)(d)1, which ordered him to appear on April 23, 2019 to answer to the complaint.
- 2. That Vani's Kitchen, Inc., by Agent Vigneshar Bhadharla, did fail to appear at the License and Health Hearing and pursuant to West Allis Revised Municipal Code § 9.02(20)(d)3, the Committee enters a default judgment and considers the allegations of the complaint to be true.
- 3. That based on the facts within the complaint that the License and Health Committee has accepted as true on April 23, 2019, and which substantially relate to the licensed activity, Vani's Kitchen, Inc. by agent Vigneshar Bhadharla, is in violation of has failed to obtain violation of West Allis Revised Municipal Code Sections 9.02(9)(c) for failure to conduct

licensed activity at the premises for over thirty (30) consecutive days, 9.02(12)(b) for failure to cooperate or appear before the License and Health Committee, 9.02(12)(d) and 9.02(20)(a) for failure to comply with the licensing requirement of obtaining necessary building inspection approval, and contrary to Wis. Stat. Sec. 125.12(2)(ag)1 for failure to comply with municipal regulations.

## **CONCLUSIONS OF LAW:**

- That through the time of the conditional approval of the 2018-2019 licenses to the
  date of the above said License and Health Committee on April 23, 2019, Vani's
  Kitchen, Inc. by agent Vigneshar Bhadharla, did fail to obtain necessary building
  inspections.
- That Vani's Kitchen, Inc. by agent Vigneshar Bhadharla had failed to appear as ordered by the License and Health Committee on March 26, 2019, and April 23, 2019.
- 3. That Vani's Kitchen, Inc. is no longer in business at the licensed premises and has not conducted licensed activity for more than thirty (30) consecutive days.

## **RECOMMENDATION:**

 Therefore, the License and Health Committee recommends to the Common Council of the City of West Allis that the Class "B" Fermented Malt Beverage License number 18-1984 and Class C Wine License number 18-1984 be revoked.
