On 05/12/19 at 2003hrs, officers were dispatched to 5732 W. Mitchell St. for a welfare check. The bartender at Uncle Fester's tavern called because an older w/m, later identified as John J. Urbanek (m/w, told her that he has "a pocket full of pills," and that he is going to the VA because "he is crazy." Officers made contact with Urbanek, who was highly intoxicated. Urbanek said that he took a whole bottle of Trazadone because he wanted to die, but changed his story several times as to when he took the pills. Urbanek said he wanted to go the VA for help, and he was transported there without issue.
