Hi Mike,

We received a letter from DPI requesting that MCFLS create a plan to bring three libraries (Hales Corners, Milwaukee and West Allis) into compliance because they did not submit their annual reports before the statutory deadline of March 1st (see attached). In that letter they state that "the system board's plan shall address each library's specific actions to ensure the libraries submit future Public Library Annual Reports by the statutory deadline including addressing any hurdles to achieve compliance that are identified by the

member libraries." I would like to help get that process started by asking (1) if there are any obstacles that we need to address at the system level regarding annual report information we provide (or do not provide) and (2) if you could start working with your board to put in place a plan to submit next year's annual report by the March 1st deadline. I will be addressing this issue formally with the MCFLS Board on July 15th so any input you have on this process would be helpful.

I realize there were extenuating circumstances this year and I do not want to single out any libraries as we address this as a system. I will be making a strong push for all member libraries to get these annual reports into DPI by March 1^{st} of next year. If we do not follow through with the plan, there is a chance our state aid payments might be delayed or reduced and I want to avoid that if at all possible.

- 1. No, I don't believe there are any obstacles at the system level that need to be addressed
- 2. The board is committed to getting the report completed earlier and steps have already been taken to address the one stumbling block assistance from the City Finance Department. With a new Finance Director in place I feel that will go a long way in improving response time for some of the data we rely on. To that end, Mr. Ziehler himself has used his familiarity and experiences with the City of West Allis and personally contacted that department. Over a period of time, the only impediment with West Allis not submitting a timely annual report has been lack of response time from another City Department, and I feel that will be improved with the current

Finance Director as she has proven to be very responsive and aware of the time element involved.

I am pleased to notify you that Milwaukee County Federated Library System's second payment for operations in 2019 in the amount of \$713,830 has been electronically transmitted. This payment will allow you to continue to carry out this year's system plan as approved earlier by the Division for Libraries and Technology (DLT).
