The owners stated they had a discussion with the Department of Development regarding opening a smoke shop at 2311 S. 108th Street and were told that would not be a problem. They then purchased the building. Upon applying for their Business Occupancy Permit, the Planning Department informed them they could not have their business at 2311 S 108th Street because it was too close to another establishment that also sells tobacco. John Stibal, Director of the Department of Development, denied any knowledge of the tobacco store and stated he is against this appeal. After discussion it was agreed by the committee that this matter be held and brought back for discussion at the May 14, 2019 meeting.
