I have enclosed a petition signed by 95% of my neighbors to deny the request of a Special Use Permit for an outside extension of a patio/smoke area at Red White and Brew located at 7127 W. National Ave.

I have personally talked to my neighbors whom have lived here for 5 to 70 years and all have expressed to me they do not want this outside extension. We have all ages from children to adults, working class people who work all different shifts. We don't want nor need to have our neighborhood disrupted with added bar disturbance.

I have a lovely backyard that I take pride in by keeping it weed free and well maintained. I can't say the same for the bar in back there are weeds taller than me and I have enclosed pictures to prove it.

A ramp was built on the West side for beverage deliveries; I have yet to see that used for that purpose. What I have noticed is that, customers are opening the door and smoking on that side instead of the front of the building.

I will give you an example of a bar that proposed a patio area for smokers that has since been extended for eating, and live entertainment. The bar on 71 and National, Braun's Powerhouse. I can hear the people after midnight talking on their patio, and I don't want to hear the people from Red White Brew across my alley which is exactly 23 yards, from the back door of the bar, to my house, and my bedroom windows face. This is way too close to have any active in the back of the bar. People do not have any respect now days and do as they please causing problems for the neighbors who live here

If you allow this permit for a so called smoking area with six tables and chairs, they too, Red White and Blue will probably want live entertainment in back as well.

With this being said, my point is that once a permit gets approved by the city it can't be undone unless it's stopped from the beginning. I already have a nice patio and don't want Red White and Brew's in my backyard.

Again I have lived here for 57 years and have seen even more with my cameras in the alley. So in closing I want to thank you for listening to my concerns and the neighbors whom have signed my petition against this permit. PLEASE you have the power to deny this and I hope you take this into consideration with the respect for myself and my neighbors.
