You are hereby notified that a sworn complaint, a copy of which is attached, has been duly made and filed, requesting a hearing on the suspension or revocation of your 2019-2020 combination Class B intoxicating liquor and beer license number 19-2589 pursuant to the West Allis Revised Municipal Code Sections 9.02(20)(a)3, 9.02(20)(a)4, in addition to Wisconsin Statute Sections Wis. Stat. 125.07(1)(a)1 and 2, Wis. Stat. 125.12(1)(b) 1 and 2.

NOW THEREFORE, you, Melissa Schrubbe for DHV Enterprises LLC, are hereby summoned to appear before the License and Health Committee of the West Allis Common Council in Room 128 of the West Allis City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, on August 6, 2019, at 6:00 p.m., or as soon thereafter as this matter can be heard, to admit or deny the allegations in the complaint. You may be represented by counsel on this date.

In the case of your failure to appear as required by this summons, the allegations in the complaint against you shall be taken as true and, if the License and Health Committee of the West Allis Common Council finds the allegations sufficient, a recommendation that your license(s) be suspended or revoked will be made to the full Common Council. The Common Council may then vote to suspend, revoke, or not renew your license(s).

You are further notified that if you appear as required by this summons and contest the allegations in the complaint, a hearing will be scheduled at a later date before the License and Health Committee, at which time you may be represented by counsel, cross examine the witnesses who testify adversely against you, and present witnesses in your own behalf. A written transcript of said hearing shall be made and you may obtain a copy of the transcript of this proceeding at your expense.

Michael Czaplewski, Alderperson for the First District of West Allis and Chair of the West Allis License and Health Committee, being duly sworn, on oath deposes and states as a complaint against ARH Enterprises LLC, as follows:

- 1. That the complainant is a resident of the City of West Allis.
- 2. That this complaint is based on information and belief established by the complainant's review of official records maintained by the City of West Allis and the City of West Allis Police Department (hereafter "WAPD").
- 3. That DHV Enterprises LLC is the current holder of a of a 2019-2020 combination Class B intoxicating liquor and fermented malt beverage license, identified as license number 19-2589, issued by the West Allis Common Council for the license period beginning on July 1, 2019 and running through June 30, 2020, for the premises located at 1641 S. 68th Street in the City of West Allis, Wisconsin; and doing business under the trade name "Dog House."
- 4. That prior to the current 2019-2020 license referenced in paragraph three above, DHV Enterprises LLC was the holder of a 2018-2019 combination Class B

- intoxicating liquor and fermented malt beverage license, identified as license number 18-2589, for the premises located at 1641 S. 68th Street in the City of West Allis, Wisconsin; and doing business under the trade name "Dog House."
- 5. That on both the 2018-2019 and the 2019-2020 licenses referenced above, Melissa Schrubbe is the registered licensing agent for DHV Enterprises LLC.
- 6. That official WAPD records indicate that on September 25, 2018 at approximately 6:25 P.M., WAPD officers were dispatched to the premises of "Dog House" for a report of a physical fight between a male and a female. Investigation revealed that the subjects had been consuming alcohol at the Dog House tavern and that the female subject began to physically assault the male subject. Officer Kyle Webster reported that he spoke with the suspected aggressor, the female subject, and noted that this female was "highly intoxicated."
- 7. That official WAPD records indicate that on September 18, 2018, the WAPD conducted a tavern compliance check at the Dog House tavern located at 1641 S. 68th Street. Officer Alexander Iskandarani and Officer Kevyn Mussatti reported that they were working in an undercover capacity in connection with Community Service Officer Abbey Bailey (hereafter "CSO Bailey") who was twenty (20) years old (D.O.B. 12/10/1997). CSO Bailey a "beer" and was never asked for identification or age. Bartender Glenn Schrubbe served the glass of beer. Officer Iskandarani noted that a different male patron at the bar appeared highly intoxicated and attempted to purchase more alcohol for CSO Bailey. Officer's spoke with Glenn Schrubbe who admitted that an intoxicated patron at the bar was causing problems and that he had forgotten to check CSO Bailey's identification.

- 8. That official WAPD records indicate that on April 17, 2019, the WAPD conducted a tavern compliance check at the Dog House tavern located at 1641 S. 68th Street in the City of West Allis, Wisconsin. Officer Adam Neimuth reported that he was working in an undercover capacity with Community Service Officer Andrew Lamm (hereafter "CSO Lamm") who was twenty (20) years old at the time of the investigation (D.O.B. 06/09/1998). Officer Niemuth reported that he entered the Dog House at approximately 9:23 P.M. and that CSO Lamm entered in plain clothes shortly after the officers arrived. CSO Lamm ordered a bottle of "Miller High Life" and was served by bartender Amanda Schoenbach without any request for identification.
- 9. That based on the incidents referenced in this complaint, DHV Enterprises LLC, dba "Dog House" has violated West Allis Revised Municipal Code (hereafter "WA RMC") Section 9.02 (20)(a)3 and 4 and Wis. Stat. 125.07(2)(a)2 for serving intoxicated persons; and Wis. Stat. 125.07(1)(a)1 and 2, Wis. Stat. 125.12(1)(b) 1 and 2 for serving alcoholic beverages to an underage person at least two times within a one year period.
- 10. That the preceding violations substantially relate to the licensed activity and are grounds for suspension or revocation of the 2019-2020 Class B intoxicating liquor and fermented malt beverage license, number 19-2589, issued to DHV Enterprises LLC.

WHEREFORE, Alderperson Michael Czaplewski requests that DHV Enterprises LLC, by agent Melissa Schrubbe, be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the

complaint are denied, that a hearing be held to determine whether the permits and licenses possessed by DHV Enterprises LLC, by agent Melissa Schrubbe, should be revoked or suspended.
