## Officer Behnke reports... Check on the Welfare

On 01/03/2020 at 2047 hours, Steven P. Miick (M/W ), the owner of Dinger's Sports Bar, located at 6139 W. Beloit Rd., called to request a check on the welfare of a male subject who acted strangely and appeared either impaired, was emotionally disturbed, or both.
