Dear Single Source,

The City of West Allis has a fast moving safety project with WisDOT to improve safety along Lincoln Avenue by improving signals at 84<sup>th</sup>, 76<sup>th</sup> and 71<sup>st</sup> Streets. (2110-00-03)

Would it be possible to amend the City real estate contract with Single Source to acquire fee and TLE from 11 parcels (3 intersections, 4 corners/intersection except one corner is historic and will be avoid)? I'm concerned about the time frame of starting a contract from scratch but I'm open to ideas...

6 parcels have 0.001 ac. fee and all 11 parcels have TLE ranging from 0.001-0.014 ac.

I've attached the draft plat that was included in a 60% plan from raSmith (who is designing the intersections for WisDOT and City). Here's the timeframe:

- Final plat in June 2020
- Approval and start acquisition in July 2020
- PS&E November 1<sup>st</sup>
- LET March 2021
- Construction 2021

If you have time to assist the City with this work, what information do you require from me to start an amendment or provide a quote for your services? I'm sure I can get titles from raSmith if that would help. Would it help if I provided information about each parcel? There's 2 gas stations, dollar general, bar/restaurant, office, 2 residents and I could gather city assessment info if that would help.

Just curious, do you know how long it would take to get an estimate of how much the real estate would cost? I'm attempting to shift money in the budget for your services and the acquisition because I thought it would be done next year 2021 and I didn't include it in the 2020 budget yet.
