
Q1 How much do you support or oppose leaving the intersection as is?



There is not any less of a distance between this intersection and the next signal controlled intersection on Beloit & Lincoln than there is between signal controlled intersections at 60th & Beloit and Burnham & Beloit. The Grant & Beloit intersection would still be a problem in the existing scenario, even with my above suggestions, which would lead me to support Alternative #1, along with the other recommendations I made earlier in this response.
